President's Report

Thanks to all for your support. As I complete my year of service as your DVCA Board President, I want to thank everyone who have made this past year at Deerfield successful. I'll try to recognize everyone but I'm sure I'll miss someone. My apologies in advance to those I miss.

Thanks to Nora Fearing for running the office and making my job go smoothly. Thanks to Flo Horton to back up Nora. Thanks to all the Board Members. Thanks to each of the Committee Chairs where all of the real work gets done. To Dan Karsten who completed 4 years as chair of Community Services, and Bill Grosse who completed multiple years as chair of Deeds, the most unpopular position, and Bob Henry who shepherded us into another year without a dues increase, to George Hintz of uncountable years to keep our security under control and to Melinda Hughes and Steve Ward for maintaining our pool and tennis facilities. Thanks to past Board members, who after their board terms, continue to serve Deerfield: Tim McGhee, who is now the Chair of Community Services; and to Craig Coleman, who serves on the Financial Services committee. And special thanks to Mike Nunez who stepped forward to guide the Deeds Committee.

I plan to step down from the Board and simply continue in one role as community Service committee person responsible for electronic communications, namely the WebMaster@deerfieldvillage.net.

Deerfield is undertaking several major renovation projects again this year. Despite rising costs and the funding of several significant renovation projects last year, Deerfield continued to have more than \$525,000 in the bank savings to fund projects. Through diligent spending, we under spent our \$450,000 budget by \$50,000. Through serious planning, the Landscape committee reduced the \$75,000 mowing contract by \$20,000. Thanks! The finance committee held the budget without an increase. Thanks again!

We are tired of constant harangues from past presidents about a lack of participation. We all make the same pleas for help. So this year, I've waited to write only one message. We need your help before we run out of volunteers.

This year we tried an alternative approach. In one instance, we started the process to examine the opportunities to outsource the duties for deeds violation tracking and reporting. We quickly heard from a small band of vocal protestors who believe the status quo is fine and don't want to see any addi-

tional costs incurred. Fortunately among the protestors we found two volunteers to come help take a turn at the management of Deerfield.

Our Village (a tribute of lexicon favored by Bill Rogan) has been instilled by active volunteerism since our inception. Now I know many of you also serve at school ,scouts, church, hospitals and other volunteer opportunities. Many have served Deerfield in various capacities for dozens of years with little recognition.

So here's my final message and plea for you to take your turn at guiding our Village. With slightly less than 100 members needed to fill all boards and committee positions, that works out to an obligation of 1 person from each of the 1058 households to serve 1 year out of every 10.58 years. So if you are new resident to Deerfield, I call upon you to schedule your 1 year (and hopefully more) of service before the 10 years go by. There's a job for everyone willing to help.

Thanks to you all who have helped in the past, and welcome to those who will step forward to serve our Deerfield Village in the future. – Bob Shortle

There were more discussions concerning the events of December 7th with representatives of ECO Resources. They have assured us that procedures have been implemented to prevent a similar situation from occurring again. Specifically they are:

- Non-emergency repairs will not be started after 12:00 pm if the repair has the potential to cause a water outage.
- ECO's IT department will add a "pop up" screen to the District's service order initiation process. This step would require an action response from the initiator concerning whether or not this Service Order will create a water outage.
- ❖ **Door Tags** will be distributed at least 48 hours prior to a scheduled water outage, such as a non-emergency tap line repair or the installation of a new main line valve.
- Signage will be strategically placed in the area of the repair as a "visual notice" to customers. Signage will include ECO's informational phone numbers.
- No work will be performed on a water distribution line without first checking that the line has been isolated.

Additionally ECO made some management changes to better improve communications within its own organization as well as with the HCMUD 136 board.

ECO also presented the board with a new payment plan that will allow for customers to pay their water and sewer bills in a number of new ways. Currently customers can only mail their checks, use automatic draft payments or go to the ECO offices in Sugarland.

ECO has asked the board to sign off on the new plan to allow customers to pay bills by credit card, grocery store payment, on-line check payment and check by phone payments. There will be an additional expense (\$2000.) to the district to set this new form of payment into place but it will allow "you our customers" a new and more flexible way to make your payments. There will also be an additional convenience charge of \$1.00 added to each payment at the time of the transaction.

The board would like to have your opinion since it is your money that is involved in this new plan. Would you or would you not be in favor of this new form of payment?

The board also considered the new 2005 budget but deferred adoption until next month, discussed but did not take action on a new electrical provider and authorized the Engineer to proceed with the calculations required for the District's Drought Contingency Plan. The board also adopted an order Authorizing Exemptions from Taxation for our over 65 citizens.

The next HCMUD 136 meeting is Wednesday, March 9, 2005 at 7:00 pm in the Deerfield Village Recreation center. Meetings are open to the public.
