We'll be starting yard of the month in April.



# President's Report

Another year for the DVCA Board is almost over. The Election of new Trustees is complete and they will begin their term on March 10, when we have our DVCA Annual Meeting for Members. Don't forget to mark your calendars and come hear the committee updates and my State of the Association comments. The meeting starts at 7:30PM. Last year our Office Manager restarted the tradition of providing cookies for those that attend. Hopefully, that will continue this year. Come out and see which committees and volunteers get special recognition.

Speaking of volunteers, we can always use more of them. Our committees are strong and doing a fine job, but there is always the need for more helpers. Last month I highlighted the Swim Pool Committee as one that needs some new folks. If your child is on Swim Team or your family uses the pool – we need you to join and help out. It only takes an hour or so a month. Community Services could also use a few more people. Come join in – it's a great way to meet your neighbors and get the satisfaction of being involved and making a difference.

I wanted to thank the Trustees whose terms have expired for their service to Deerfield. First to Marie Nugent for multiple terms on the board and continued committee involvement, second to Walt Bohn for filling an unexpired term and now re-upping for another three years, and lastly to Carolyn Dinger who had to resign a bit early due to a personal situation. These three and the other Trustees are due a great deal of thanks for the time and commitment they make for all of us! Also, I wanted you all to know that there will be a new President after the Annual Meeting, as I believe that two years is long enough, and someone else should have the opportunity.

I want to give you an update on trash pickup for Deerfield. We renewed our contract with Allied Waste as there was no other option available. When we went out for bids, we found that very few companies are interested in the DVCA contract because we require them to do individual billing to each of our members. The two bids we did receive were from Allied Waste and Republic, which then merged – so in the end we had no options. As a result, the board negotiated for and signed a one year contract only and has started to look for other ways to handle the trash pickup. One of the best we've identified is to have MUD 136 (which is responsible for DVCA) take over this responsibility, as we understand that it is something that many MUD's already do.

We started discussions about this with the MUD 136 board in January, were able to get on their agenda, and had a very positive twenty minute exchange of information at their February Board Meeting. At the meeting we found out that it is very common for MUD's to handle trash pickup. In fact, a majority of the MUD's in the area already do this for their homeowners. Our MUD already does individual billing, so they could get bids from the waste management companies that refused to bid with DVCA. This could result in a more competitive service and rates for the residents of Deerfield. **Please let the MUD Directors know** your appreciation of their considering this and working with DVCA to help all of us stretch our limited budgets. We have asked that they provide us a decision on this in the near future, as if they don't agree we will have to come up with another (probably substantially more expensive) option. We'll keep you posted on the progress. I have offered to be the DVCA Board liaison with the MUD Board as we work through this and will keep all of you posted on the progress.

Finally, it's time to start spring cleaning and getting our yards back in shape after the winter. The drought certainly hasn't helped any. If your yard or house needs some sprucing up, please take care of it and help keep Deerfield looking nice. Thanks!

## Deeds

Deeds meets the first Monday of the month @ 7PM

The Deeds Committee would like to say “**Thank You**” to all the residents who keep their properties maintained and to those residents who fix their violations when asked. It is the cooperation of all the homeowners that will keep Deerfield Village safe and beautiful!

If you do receive a violation letter that requests action to be taken, please let the office know when you intend to have the work done. We can monitor your home until the work is completed, and you won't receive any further notices. We understand that you may need to get bids and make financial arrangements in some cases, so we just ask that you let the office know you are working on the problem in a reasonable time frame. If you don't respond, then you receive a 2<sup>nd</sup> violation notice. If you still don't respond, you may receive a 10 day notice or the violation will be turned over to the Board for legal action.

It costs all of us money to send letters or to take legal action to every homeowner that has a violation so it is extremely important for all of us to keep our properties in compliance with the Protective Covenants. You can get a copy of the Protective Covenants on the web site at [www.deerfieldvillage.net](http://www.deerfieldvillage.net) and select the Protective Covenants link.

We are still noticing a lot of yard clippings and trash cans out several days prior to trash pickup (especially over the weekends). Please have your garbage out of view until the night before pickup or have your yard crew take the clippings with them. This is becoming a major problem and we ask your cooperation in fixing this problem. Please help us by reminding your neighbors if you see any violations.

**Reminder: Boy Scouts are getting ready to delivery mulch and we ask that if you are not spreading it out immediately that you have them store it out of sight.**

We “Thank you” in advance for you cooperation.

## Swimming Pool Committee



The Pool will open to the residents on Saturday, May 2<sup>nd</sup>, for Saturday/Sunday's only. The first hour will be for adult swim (10:00 AM) except on swim meet days. A monthly schedule will be in the newsletter starting in May.

We have been asked by a resident what residents can use the pool. Naturally, homeowners and their families living in Deerfield can use the pool. Homeowners who are renting will need to write a letter authorizing the renters/leasers to use the pool. Homeowners renting out their homes who authorize the renters to use the pool can not also use the pool. In all cases the homeowners must be current in their Deerfield assessments.

Pool IDs' will be required in 2009. The use of ID's has helped reduce non-resident use. . We will be updating 2008 cards with a 2009 sticker, so those who already have a card will not need a new one. If you have your card you will need to bring it by the office to be verified and get a sticker for it; if your card was left at the pool, we will apply a sticker. If you do not have an ID yet, we will making new ID cards on March 28<sup>th</sup> at the Music on the Green, and at the Easter Party in April. Cards will be checked once the pool opens in May, and by June, residents will need a current ID card or will not be able to use the pool facility. Remember, you must be current on your Homeowner's Association dues to have an ID card and use the pool

## MUD 136 BOARD REPORT

At its February meeting the directors reviewed the results of January's business. During January, the District produced 11.3 million gallons of water versus 9.86 million in January, 2008. For the full year 2008, the production was just over 190 million gallons versus 150 million in 2007. Some interesting facts about water. 75% of the earth is covered with water, but 97% of that water is too salty to be used. Of the remaining 3% fresh water, 2% is tied up in glaciers, ice caps and permafrost, or is too far underground to be of use. We humans are dealing with 1% of the world's water. Conservation of this precious resource is essential. Let's all make a concerted effort this year to bring our water consumption back down to the 2007 level. The directors voted to engage McCall Gibson & Co. to perform the audit of the District's financial records for 2008. Records of the District's business are open to the public. Audited financial results for the previous fiscal years can be reviewed on the District's website. The website has a new and improved look thanks to the efforts of director Harry Price, who has taken on the job of webmaster.

If you have questions about any aspect of the District's operations, you can ask them during the resident comment period at the beginning of our monthly meeting, which is held on the second Thursday of the month at 6:00 PM at the rec center. ### Timely Tip for March Cornelius Gardeners

Create Instant Color!

Container gardens are fun and easy to create. They can be as simple as three small flowers potted together or as elaborate as a small tree or shrub planted in the center of pot with annual color planted around. Follow these simple steps when planting or plan on attending one of our FREE Container Garden Clinics in March.

**First** select a container appropriately sized for the job. Make sure it has drainage holes and is large enough for making an impact. **Second**, choose a well blended potting soil that drains well. **Thirdly**, choose plants that require the same lighting and water needs. The **fourth step** is to start planting. Fill the container half way with soil, position the plants and start filling in with the rest of the potting soil. You can also add a fertilizer such as **Calloway's Professional Flower Food** into the soil. **Lastly**, I add a top dressing of decorative bark or mulch. This adds the finishing touch, plus it will keep the soil cooler and prevent it from drying out as quickly.

After you have completed your masterpiece, sit back and watch it grow! Now you are ready to start planning your next one! Enjoy!


