

President's Report

By the time you read this, the ditch should be completely clean. Ta Da! Flood Control has done a good job. They did more than expected by cleaning out the side drains from the streets as well as the ditch itself. That should help drain the whole subdivision much more effectively. Now, it's up to us to do our part by not throwing leaves, grass clippings etc. down the catch basins. As the signs the scouts placed on them say, "the basins are not garbage cans". Moreover, don't let your yardmen do it either. Not only does bulky debris slow the water flow preventing a good flush of the sewers and ditch, it's illegal.

I initiated action to have Flood Control sow the ditch with wild flower seeds. Don't expect this to happen over night. The wildflowers will help stabilize the sides of the ditch keeping dirt from sluffing onto the concrete providing a base for weeds to grow. They will also provide a show of color each spring not to mention making it easier for school kids with their wild flower collection project.

One last thing regarding the ditch: After the flooding in April there was some concern that the flooding in the patio homes may have been aggravated by blockage in the patio homes storm sewer lines. When apprised of this concern, MUD 136 initiated action to have all of the sewer lines in the patio homes inspected with a television-like survey instrument. The results of the survey showed some very minor accumulations in a few locations that in no way contributed to the flooding. Those accumulations have since been cleared to prevent them from becoming potential problems. I would like to thank the MUD Board for addressing the situation so promptly and effectively.

I am on Wilson's CPOC (Campus Performance Objective Council) as a community representative. At the last meeting, a presentation by Dr. Anthony, Superintendent was viewed. The presentation was a concise overview of the how's and whys the Cy-Fair School District got into its present budget crunch resulting in a 2010-2011, \$10 million shortfall and how the District is planning to overcome that short fall. If you are at all concerned about the education of DVCA kids, you should view the presentation at www.CFISD.net. Part of the plan is to accumulate cost-cutting ideas from the public through a very open-ended survey. You can let your views be heard by participating in that survey, which can be accessed on Cy-Fairs web site as well. You need to hurry because the survey needs to be submitted by October 30. Even if you don't want to take part in the survey, you owe it to yourself to view the presentation. It's very informative and really not that long.

If you want to help make decisions that directly affect the quality of your life in Deerfield Village, join the Community Services Committee. Perhaps no other committee has such wide-ranging responsibilities. Here's a brief, but far from exhaustive, list of what the committee oversees:

- Lighting and electricity for the Recreation Center and Greenbelt
- Lighting for Patio Homes
- Vandalism repair
- Deerfield Newsletter
- Deerfield Web site
- Communication through blast emails

In looking beyond a simple listing of the committee's responsibilities, we make decisions about the facilities and services that affect the daily life of every Deerfield resident. Most of us don't have to think about these things, and that is how it should be. We should expect our trash to be picked up; our children to have safe, clean, places to play; well-appointed rooms for meetings and social events; a well-lit Greenbelt for walking our dogs, exercising and moving around the neighborhood; an environment free from blighting graffiti; and an effective communication system for important neighborhood news that affects our security and enjoyment of life. That's why we choose to live in a neighborhood like Deerfield.

Unlike many neighborhoods, Deerfield is run by those of us who live here, not a paid management company with no vested interest in our lives. That's why our association management fees are among the lowest in the area for a well-maintained, quality neighborhood like Deerfield. And although we have over 1,000 families who live here and enjoy the amenities, the Community Services Committee is currently made up of six members and a dedicated board representative. In most instances, membership on our committee is not an inordinate drain on your time. We all have jobs, families and many outside interests.

The Community Services Committee has monthly meetings that usually last no more than an hour. We all help with research and discussion of projects and proposals. Sometimes we need to make a "field trip" to observe lighting or other conditions. And we have fun – we take our business seriously, but we are a friendly group that likes to laugh and enjoy what we do, because we believe in our neighborhood and our neighbors.

I have served on the Community Services Committee for five years and had the privilege of chairing the committee for the past two years. TREES AND FENCES!

Dead trees are everywhere! DVCA is having the trees removed in the common areas as fast as possible. The Deeds Committee would like to ask residents with dead trees to also try to remove their dead trees promptly. The dead trees could pose several hazards and cause more property damage for you or your neighbor if the dead trees were to fall or catch on fire. If you have a dead tree and are waiting for a tree company to remove it, please let the office know when the tree is going to be removed. This could help us tremendously so that we don't waste time and postage sending you a letter to ask for it to be removed.

We are also noticing that many fences are either missing pickets, have broken pickets, rot boards falling apart or fences are leaning throughout the neighborhood and especially along the perimeter of Windsong Trail. We would like all homeowners to please check your fences and make the necessary repairs. Again, this would save us a lot of time and money if we did not have to send a letter to every homeowner to repair your fences properly!

If you would like to report a violation please call the office manager. The Deeds Committee nor the manager can tell you what is being done about a specific property so please do not call and ask. We do everything we can to resolve issues with homeowners in a timely manner but sometimes we don't get cooperation from the homeowner. We have now taken several properties to a lawyer and are in the process of filing lawsuits to get results. Again, this does not happen overnight...please be patient! We are doing everything we can to keep Deerfield looking great!

Cornelius Timely Tip for November

Planting Spring Flowering Bulbs in Fall



Spring flowering bulbs are such a welcoming sight after those long Winter months. Many of the Spring flowering bulbs require an artificial "chilling" process before they can be planted. This is generally accomplished by placing the bulbs in a paper bag in the vegetable crisper of your refrigerator for six to eight weeks prior to planting. However, Cornelius Nursery is offering to do that for you. We have many varieties of Tulips, Hyacinths and Narcissus which you can purchase from our stores now and pick-up in December ready to plant. Let us simplify those "chilling" requirements!

We also will be offering pre-chilled Tulips and Narcissus bulbs online at <http://mytexasgarden.com/index.php/estore/>.

When planting bulbs, the general rule is to plant them at a depth three times the diameter of the bulb. Use Calloway's Blood & Bone Meal at planting for added nutrients. Plant the bulbs pointed end up, cover with soil and water thoroughly. For the best display, plant bulbs in clusters or uneven numbers. Apply two to three inches of mulch on top of the bed.



MUD 136 BOARD REPORT

At the October meeting the directors adopted the tax rate for the tax fiscal year that begins September 1, 2009. The tax rate will be \$0.27/\$100 assessed valuation, which is the same as last year. The tax rate is composed of 5.5 cents going to debt reduction, 21.5 cents going to maintenance and operations. If you do not receive your tax bill by December 15, contact the District's tax collector, Bob Laird Interests at 713-932-9011. You can also find your bill on their website www.bli-tax.com. Click on Records and enter your street address. Then click on the account number that appears in the left hand box.

On September 28, the District's began receiving water from the West Harris County Regional Water Authority (WHCRWA). We will continue to produce some water from well #1, which will serve our back up should there be any interruption in the supply from WHCRWA. Our second, smaller well will not be used.

The process to select a garbage collection contractor continues. We have received several proposals which we are reviewing. We expect to complete the process and make our selection at our November meeting.

New Deerfield Web, Email Policies Approved

The Deerfield Village Board of Directors has approved new policies for the Deerfield Web site and blast emails, as proposed by the Community Services Committee. The policies were developed to provide fair, effective, timely communication to residents regarding news and activities that are directly related to the safety, security and quality of life for all residents in Deerfield Village. In addition, the policies will assist the volunteer who maintains the Web site and distributes emails.

Blast Email Policies

Blast emails may be sent to residents to provide information that is time-sensitive and important to the safety, security or quality of life in Deerfield, in keeping with the neighborhood's articles of incorporation, which state that Deerfield Village is a non-profit corporation organized exclusively for civic, educational and recreational purposes. Emails will be sent to all residents who have provided a current email address to the office manager. The following guidelines will apply:

- All information for emails must be submitted to and approved by the Deerfield office manager. The office manager will instruct the Deerfield Webmaster to distribute the email.
- Blast emails will normally be sent on Tuesday evenings. Information must be submitted to the office manager by noon on Monday. Additional emails may be distributed if approved by the office manager.
- Emails will only contain information that is relevant to the safety, security or quality of life in Deerfield Village. Advertising for businesses or services, political or religious creeds or opinions, or activities not directly related to Deerfield Village will not be allowed in blast emails.
- Examples of information that may be sent by blast email include information related to services such as drainage, trash pickup, disaster preparedness or relief, activities sponsored by Deerfield Village or a Deerfield Village standing committee, notices of community meetings, and other information relevant to quality of life in the neighborhood.

Must Know Information from the Manager.....

- * Reporting criminal activity to the office is helpful and appreciated, but **please call the constable first to file a report.**
- * Visit our website at www.deerfieldvillage.net. Most of the information requested can be found on the website. To report a street light, you must know the pole # and address. Lights on the Greenbelt or in the patio homes needs to be called in to the office.
- * There is a locked drop box for your convenience located next to the office windows.
- * Office hours are from 9:30 to 1:30. If you can't make it to the office during those hours to pick up a key etc., please email the office to make arrangements with me to meet after hours. Please do not call me at home for Deerfield Business. I typically do not get the messages.

Web Site Policies

The Deerfield Village Community Association maintains a Web site to provide information for residents in keeping with the articles of incorporation, which state that Deerfield Village is a non-profit corporation organized exclusively for civic, educational and recreational purposes.

The site is currently maintained by a resident volunteering as Webmaster. The following guidelines apply to the Web site:

The Web site is maintained to provide information to residents of Deerfield Village that is relevant to the services, safety, security and activities available to all residents of Deerfield.

- The Community Services Committee has oversight for the Deerfield Web site, and the Webmaster is a member of the Community Services Committee. The Deerfield Village Board of Trustees approves the Web site policies, as proposed by the Community Services Committee.
- Each section on the Web site will have an owner that takes responsibility for the content of that section. Owners are defined as the Deerfield Board, the office manager, and standing committees.
- All information posted to the Web site, other than updates to existing information or previously approved notices, must be approved through the Deerfield manager's office.
- Information that promotes business ventures, political or religious creeds or opinions, or activities not related to Deerfield Village will not be posted on the Web site.
- Advertising will not be allowed on the Web site. Advertising is available in the Deerfield Village News monthly newsletter, which is posted on the Web site.
- Information on the homepage will be posted until it is no longer timely or until no longer relevant to residents. Information will be removed after 30 days unless it is re-submitted to the office manager.
- Information in other sections should be updated by the responsible parties as often as possible to keep the information fresh and relevant. Updates should be done on at least a monthly or annual basis, depending on the type of information.
- Some committees may have access to administrative rights on the Web site in order to keep the most up-to-date information posted regarding their sections of the Web site. Any committee that would like to obtain administrative rights to their portion of the site must submit a request to the Community Services Committee.
- The Webmaster may make determinations on the timeliness and appropriateness of information as stated in the guidelines, and may remove it when no longer relevant or when it meets the previously stated guidelines on length of time for posting.
- The content of the entire Web site will be reviewed by the Community Services Committee on at least an annual basis for relevance of content and to ensure the site is providing information that residents need to maintain safety, security and quality of life in Deerfield.


