President's Report

Greetings Deerfield Residents,

It's been one year since Harvey, and things seem to be a lot quieter this year. I received a nice note from the Constable's office, which was posted on Nextdoor titled, "From the bottom of our hearts". They thanked Deerfield for all the support we gave them, including turning the Clubhouse into a mini substation. By allowing use of the Clubhouse, they were able to lodge 70 deputies and save 25 patrol cars from being flooded. Those officers, who had families at home by the way, were able to rescue around 3,000 people and 400 animals. They called us their Harvey heroes, but they were the real heroes. From the Deerfield community and it's Harvey heroes, thank you officers of PCT 5 during Harvey, and all you do every day for the citizens you protect.

Please note that in September, the pool hours change, as kids go back to school. We will be open weekday evenings and on weekends thru September. We also have lots of activities that are coming your way, including the big Labor Day party. Please check your email blasts, and the newsletter posted on the website.

In my report last month, I reminded people that Nextdoor is not an official channel to get HOA information, and you can't believe everything you hear on that site. Unfortunately, I still see some postings that refer to HOA related business, with much misinformation. I have decided to create a column called, "Nextdoor Verified", and I will try to tackle issues I see. Depending on the volume, I may have many posts, or none in a given month. At least if you see something on social media sites, like Nextdoor, you can refer to a previous post, or read about it in the next month's issue. If you are not on Nextdoor, no worries, you will see the issue being addressed and an answer in the newsletter.

Speaking of posts on Nextdoor, let me take the post I saw called "Lifeguard petition" which really was an inquiry to a rumor that Deerfield is considering getting rid of lifeguards. This is false, there is no plan to remove or reduce the hours at the pool with a lifeguard. The resident that made the request stated to me that she was asking for the HOA to consider allowing the pool to be used during off hours to adults or supervised children. This type of swimming is called "Swim at your own risk" similar to what you see in some HOA's, apartments, hotels, etc.. In this case, the pool would not be open to all residents, but residents that "Optin" and would sign and be subject to additional rules. So,

by default, the access control system would not allow any person without a waiver on file, and you must ask for access, into the pool area. It's likely that there would be routine checks by SEAL, and consequences would be high if found in violation. For this to be considered, many questions must be answered. When a group of residents, also known as "Members of the Association" make such a request, it is the duty of the HOA to review and consider the request. That does not mean that it has approved or denied the request. As a result, the Swim Pool Committee has created a subcommittee to focus on the request and its feasibility. They will make every effort to see if this can be accomplished, and/or report back if it can or can't be done with reasonable accommodations/risk. That recommendation will be made to the Swim Pool Committee for consideration, and then to the Board for consideration. More to come on this request, and no proposal has yet been made. However, please attend meetings if you are for or against this proposal, once it is published, or to make your voice heard.

Keep Deerfield Bright at Night...

Please report Street Lights and Greenbelt Lights that are out to the DVCA Office; phone: 281-463-2624. It is necessary to provide the pole number and the location address of the pole that is being reported. Street Lights that are not on the Greenbelt and not in the Patio Home Section may be reported directly to Center-Point Energy at the following website:

http://www.centerpointenergy.com Click on the "Report a Streetlight Outage" located in the middle of the page. You can then click the "request form" and complete the requested information and submit.

Nothing but water should go down our storm drains.

Please make certain that the grass/yard clippings along curbs are bagged. In case of a heavy rain, these clippings will be swept into the sewer system and block the runoff water; which in turn will flood our streets.

Residential Trash Reminders

Please know that there is a 15 bag limit in regards to yard debris per service day. Anything over this limit must be negotiated between the home owner and Waste Corporation of America: 281-368-8397. Hours of operation are 7 am to 7 pm, office hours are 7 am to 4 pm. Pick-up days are Tuesday and Friday. Heavy trash day is Friday, limit 1 heavy item per service day per household. Please do not put your trash out until Monday or Thursday evening.

Deeds Committee

We continue to make progress on improving how the Deeds committee works and how we interface with the Deerfield residents. Our efforts in dealing with some of the bigger violations are having good success with an over 80% response rate and agreement to work on fixing the violations by those residents where we have needed to escalate and address the issue more formally. Please understand that in some cases this is a very slow process as there may be a legal process that we have to follow, which normally is slow and tedious. We have started to bring in the DVCA attorney and local authorities to help us. And there are a few cases where neither we nor any of the local or state entities have power to address the issue. That is very frustrating when it occurs!

Thanks to all of you who have responded to a letter from Deeds, have established a dialogue and are working to resolve or have resolved your violation.

In general, DVCA is aging well and looks good. But we do have some issues that need to be addressed.

Curb Appeal of our yards:

• Lawns: Our large and mature trees are both a blessing and a curse. Many of us with them are losing the battle to keep a lawn growing under them. And when you add in Harvey, the very hard winter and freezes, and now a very hot summer moving towards a drought, it is really impacting the curb appeal of our homes (and causing Deeds to consider sending out letters). Dirt, weeds and roots just don't look good at all! We know now is not the time to try to plant new things, but are asking you to start thinking of what you can do to make your yard more attractive this fall after things cool down a bit.

Randy Lemons of KTRH Garden Line says it is hopeless to try to grow most grasses under mature trees, so we need to get creative with ground covers that like shade (such as Asian Jasmine, Monkey Grass and Liriope), rock gardens and mulch. There are some homes in Deerfield that have already done these things and they look nice. We will work to provide more information on this in future newsletters. Please get your creative juices working so that our yards look better for the Holidays.

- Beds around the house and trees: The past years' extreme weather conditions also impacted many of our plants and bushes, but it seems like the weeds weren't impacted. Please neaten up your beds by pruning your plants and pulling out weeds and dead bushes. It can really help improve your homes curb appeal.
- Vehicles not parked on the driveway. Vehicles are not allowed to be parked in the yard off of the driveway. We have too many people doing this and we have started sending letters to ask you to either stop it or submit an Architectural Approval (AA) form for the expansion of your driveway. Thanks to those of you who have stopped and/or have submitted an AA to expand your driveway.

• Storing large items for over 72 hours on your driveway or on the street: Boats, RV's trailers, inoperable or covered vehicles that are parked on the driveway or on the street need to be kept in the garage, moved to a storage facility, or screened from view of the street. It is fine to store them there for a couple of days when preparing to use them or cleaning up after use – but they do not belong there long term. We are sending more letters about this than we should have to. Please be considerate of your neighbors.

Fences:

We have had a lot of fence issues in the last several weeks, and there are too many fence projects that have had to be redone at the resident's expense. We don't like to do that, so please submit an AA form before you start work on a fence.


An AA form is required to be completed and approved before you replace or add any fencing, as there are standards that must be followed for any fence built in Deerfield. If your house has a perimeter fence or faces the common areas, there are additional standards that need to be met. Deeds ensures that these standards are followed, so help us help you by submitting an AA.

Using Architectural Approval Forms:

Although many of you are submitting Architectural Approval forms for any external change you want to make on your property, there are still too many that aren't. They are required to be filled out and unfortunately we continue to have instances where an AA form was not completed and approved in advance, and the changes violated our Protective Covenants. So Deeds has had to contact the residents and tell them that their project was not compliant and that they needed to either: 1) submit an AA form with plans on how to make the changes compliant or 2) undo the changes. This is frustrating to both the resident and Deeds and not something anyone wants to have to do. So please submit an AA form before you start.

The AA process is becoming easier and Deeds has improved the approval process, typically responding in less than a week versus the 30 days typical for most management companies.

The next Deeds Committee meetings will be on Wednesday September 12th and Wednesday, October 10th in the Club house at 7pm.



Security Committee

Summer break is coming to an end and by the time you read this, school will be back in session and our typical summer mischief should be behind us. Remember to be careful for our children as they go back and forth to school. We don't want any accidents!

Be a good neighbor! Slow down and drive safely!

Last month was pretty quiet except for one night when we had three more crimes of opportunity where unlocked vehicles were broken into. Please keep your vehicles locked when you are not in them, remove valuables to your home, and park in a well-lit location.

Speaking of parking, we are having more issues and complaints about street parking. We know that many of our residents park on the street and would ask you to be considerate of your neighbors when you do.

Park in front of your own house if you can

Try not to park in front of someone's mailbox, causing them not to get mail

Try not to park across from a driveway. This causes difficulty backing out and both cars could get damaged.

Try not to park directly across from another parked car. It makes it difficult to use the street and may block an emergency vehicle from getting where it needs to go.

Don't park a vehicle, especially a trailer or larger truck, on the street for long periods of time. If you

do, it could be ticketed and/or towed.

Be a good neighbor! Park considerately!

New signs were put up at the entrances of the greenbelt by the county. These are not meant to impact any of your normal activities of walking, running, or being on the greenbelt. They were put there so that charges can be pressed when we catch the person who speeds down the greenbelt on their ATV or any other motorized vehicle.





Landscape Committee

The Landscape Committee welcomes Art Blummer as a new voting member. Art attended a meeting a few months ago requesting permission to install an additional purple martin house and ended up becoming a member of our committee. We are thrilled to have him.

After several months of discussing the progress on the Clay Road entrance, the work is finished. The committee is very appreciative of the board's support on this project and we think everyone would agree that it turned out beautifully.

To the Thursday Morning Men's Group, thank you for power washing the Deerfield Village sign. Soon they will be touching up the paint on the lettering. Again, thanks to all involved in this effort.

With the help of the Men's Group we are replacing the purple martin bird houses that were originally placed in DVCA by the Boy Scouts. These houses will initially be placed in the common areas with hopes of expanding.

Purple martins are glossy deep blue, almost black delta winged birds with a forked tail. Martins are beautiful, graceful, clean, interesting and beneficial birds. They literally fill the air in summer, singing their hearts out and eating large quantities of insects that could otherwise be pestering us.

Early Native Americans prized the purple martin and offered houses of hollowed out gourds. We would like to provide both gourds and apartment style housing and receive the beneficial natural insect control. Purple martins enjoy being around people and most are dependent upon humans for their shelter.

Most purple martins migrate to South America during the winter, but frequently return to the same breeding spot year after year. Purple martin scouts appear beginning January or February, depending on the weather.

water and sewer operations during the previous month, including a discussion of trash pickup and household Our recycling program does not include electronics, nor does it include document shredding. Therefore, we are having a special event to cover these. It will be held in the Rec Center parking lot from 9am until noon on Saturday, October 20, rain or shine. Details can be found elsewhere in the newsletter. Signs will be posted around Deerfield a few days before the event. Last month's article noted that the District this year has been supplying from its own well almost half of the water delivered to homes. Normally we would be supplying only 1%. To reduce the strain on our operating system, we are asking residents to increase their efforts to conserve water. Here are some suggestions. Check for leaks. A dripping faucet can waste 2,700 gallons of water annually; a leaky toilet can waste 200 gallons per day. Check for a toilet tank leak by adding food coloring to the tank. If that color appears in your toilet bowl within 30 minutes, you've got a leak. The toilet is the largest user of water in your home. Any toilet installed before 1992 is likely wasting water. Replace it with a unit that uses 1.6 gallons per flush. The second largest user of water is your washing machine. Use an Energy Starrated machine with a Water Factor of 9.5 or lower. It will use 35 to 50 percent less water and energy per load. More ideas can be found at water.tamu.edu.and at www. whcrwa.com).

Financial Services Committee

The expense overage shown above is a large increase from last month. Most of that is due to the expense of the renovation and repair of the annex stairway. In addition, we continue to show year to date overages due to timing issues, from expenses incurred earlier in the year than they were budgeted.

The YTD assessment collection rate is 97.6%. This is 0.1% better than the 2017 comparable rate.

Work on 2019 budgets is underway by the various committees. Drafts are due back to the Finance Committee by September 1.

2019 Assessments

The 2019 DVCA Assessment will be announced in late October or early November.

However, if you want to avoid a cash crunch in December/January, you can start prepaying your 2019 Assessment early. To do this, start sending in monthly amounts, say \$100.00 or whatever amount fits your budget. Make sure your Deerfield Village address appears on the check. Send payments to:


