## President's Report

Greetings Deerfield Residents,

The Finance Committee has been working hard with all our Committees to finalize the 2019 budget, and we have a planned meeting between the Board and Committees on October 15th to approve that budget plan. Anyone is welcome to attend that meeting.

Please note that the pool is now closed for the 2018 year.

I'm pleased to announce the opening of a new amenity for all our residents. We now have two pickleball courts painted on Tennis Court #4. I know many of you enjoyed the pickleball day event we had over the summer, and we now have permanent courts. Please be sure to sign up for the court on the signup sheet located by the office window.

I didn't see anything to report for Nextdoor verified this month, which is a good thing.

I want to thank all of you that came to the blood drive for Troop 120 Zach Stebbins project, and I know the donations of blood will help many people in a time of need.

Another development, we have formally created a perimeter fence subcommittee that will investigate again the feasibility of an HOA owned perimeter fence. This was done 10+ years ago, and that committee was not able to justify the project. One of the big reasons they did not move forward was because for the HOA to build and maintain a fence, the property must be owned by the HOA. There were going to be issues obtaining the easement deeded over to the HOA. Additionally, the vote by residents were divided, and there was not a majority vote. Since a significant amount of time has gone by, we are revisiting the feasibility, based on some resident feedback.

At the September Board meeting, it was brought up that a Spanish newsletter being delivered by the Houston Chronicle can cause the storm drainage to be clogged. Since this is an unsolicited newsletter, I will contact the Chronicle to see if they can deliver differently or discontinue distribution in Deerfield. With the heavy rains we get, we don't need more debris clogging up our drains, and polluting the environment. I'm hoping for a positive response.

Our last music on the Green for the year is October 6th, so come out and enjoy the cooler weather and the music.

Lastly, I hope everyone has a fun and safe Halloween. We will have our traditional Trunk or Treat on Halloween night at the Recreation Center parking lot for the young Trick or Treaters. Please drive cautiously when coming home from work, as the kids start Trick or Treating early.

## Keep Deerfield Bright at Night...

It is necessary to provide the pole number and the location address of the pole that is being reported. Street Lights that are not on the Greenbelt and not in the Patio Home Section may be reported directly to Center-Point Energy at the following website:

Click on the "Report a Streetlight Outage" located in the middle of the page. You can then click the "request form" and complete the requested information and submit.

## Nothing but water should go down our storm drains.

Please make certain that the grass/yard clippings along curbs are bagged. In case of a heavy rain, these clippings will be swept into the sewer system and block the runoff water; which in turn will flood our streets.

## Residential Trash Reminders

Please know that there is a 15 bag limit in regards to yard debris per service day. Anything over this limit must be negotiated between the home owner and Waste Corporation of America: 281-368-8397. Hours of operation are 7 am to 7 pm, office hours are 7 am to 4 pm. Pick-up days are Tuesday and Friday. Heavy trash day is Friday, limit 1 heavy item per service day per household. Please do not put your trash out until Monday or Thursday evening.

# Deeds Committee

We have been getting feedback that many of you are appreciative of the new focus of Deeds. Thank you! And thanks to the vast majority of you that take pride in your home to keep it looking nice and attractive. The neighborhood is looking better and we are beginning to see results from our focus on some of the bigger violations. In most cases where we have escalated, the residents are responding and working to resolve the violation. Thanks to all of you who have responded to a letter from Deeds by establishing a dialogue and working to resolve or resolving the violation. For those that have not responded, we are taking next steps with the DVCA attorney and local authorities.

We have heard some feedback about our push to keep trash bags off the streets between trash days. Some think it's great and others think it is picky. For those who think it is picky – we have a question. If it is too hard for you to take the minute or so it takes to move a trash bag from the street to behind a screen or into the back yard, then how can you expect anyone else to take even more time and effort to resolve the bigger issues that make the neighborhood look bad? Just a thought. Moving the trash bags is just a simple matter of being considerate to your neighbors.

Here are a list of things we'd ask you to look at doing as well.

## Curb Appeal of our yards:

- **Curbs:** We have noticed that there are many homes where the curbs have become very unsightly with lots of dirt, leaves, and pine needles reaching out several inches into the street and piled up to an inch or two high. Some are even growing weeds. If you have a curb like this, please get it cleaned up. The street look much better.
- **Lawns:** Starting next month we plan to add pictures of homes in Deerfield that are using creative alternatives (ground covers, rock gardens, mulch, etc.) to a yard that won't grow grass anymore. We want to provide some ideas to address the problem where yards are becoming just dirt, weeds and roots. This doesn't look attractive and adversely impacts the curb appeal. If you have this situation please start considering what you can start to do this fall to remedy it
- **Beds around the house and trees:** Now that fall is here (and it's a little cooler), please take time to look closer at neatening up your beds by pruning your plants and pulling out weeds and dead bushes. Your yard will look much better.
- **Storing things in view of the street:** Our protective covenants do not allow for storing items in the front yard that can be seen from the street. This includes garbage cans, construction materials and debris, tools, shelving, etc. All these things need to be stored out of view in the back yard or behind some sort of a screened area that has been approved by Deeds. Additionally boats,

RV's trailers, inoperable or covered vehicles that are parked on the driveway or on the street are not allowed stay there for over 72 hours. If you have any of these, please keep them in the garage, behind an approved screened area, or move them to a storage facility.

## Fences:

This is repetitive from last month, but we continue to have issues for fences that have been built but don't comply with the Protective Covenants and did not have an Architectural Approval form submitted (or approved). There are four recent cases where the residents have had to take down or redo their fence project as a result (at the resident's expense). That is an undesirable outcome for all of us. Please submit an AA form for approval before you start work on a fence.

An AA form is required to be completed before you replace or add any fencing, as there are standards that must be followed for any fence built in Deerfield. If your house has a perimeter fence or faces the common areas, there are additional standards that need to be met. Deeds ensures that these standards are followed, so help us help you by submitting an AA.

## Using Architectural Approval (AA) Forms:

The AA process is becoming easier and Deeds has improved the approval process with a response time averaging less than a week. We're trying to make it simpler and quicker for you.

**Remember:** You are required to fill out an AA form for all external changes made to your house or yard and to not begin any work until the AA form has been approved. Failure to do this may result in you having to undo or redo the work you have done (at your own expense). Unfortunately we continue to have instances where this has occurred, and it is a hard situation for everyone involved. To make all of our lives easier, please submit an AA form for approval before you start any project!

The next Deeds Committee meetings will be on Wednesday, October 10th and Monday November 5th in the Club house at 7pm.

  - o It makes it difficult for everyone to use the street
  - o It may block an emergency vehicle from getting where it needs to go.
- Don't park a vehicle, especially a RV trailer or larger truck, on the street for over 72 hours. If you do, it could be ticketed and/or towed.

Please remember to drive carefully on the evening of Halloween, October 31. We will have lots of activity on the streets and we don't want anyone hurt.

# Pet Hotline News

-  Make sure your pet has a form of ID on their collar. Key tags are available 3 for \$2.00 at most hardware stores and work fine for pet ID's.
-  Did you know that you can register your pet with Deerfield's Pet Hotline? Call Marie Nugent, 713-818-5799 for a Pet Hotline tag for your pet. The tag has Marie's home and cell phone number. She keeps a log with a photo, breed, pet's name, and your address, and phone contact numbers. A rabies tag is a great ID, but many Vets are not contactable 24/7 and the finder may not be able to keep your pet for several days.
-  If you have your pet microchipped, make sure you register on the database and keep your information current. Pets have been found wandering around the neighborhood and, when taken to the vet, found they were microchipped but the information was obsolete, thus making it harder to contact the owner.
-  If you are going out of town and have a pet sitter, let Marie know your pet's name, what it looks like (a picture is also great), and a contact number.
-  And if you are thinking about owning a pet – Ask yourself IF:
  - You have time to get its shots and check for heartworms
  - You have time to get a collar with ID and a phone number on the tag

# Landscape Committee

The Landscape Committee received calls about broken tree branches and a few people have mentioned some of the trees along the Greenbelt appear to be dying. An article in the Houston Chronicle this month stated that the weather extremes experienced during the last 12 months starting with the flooding from Harvey, the ice and snow during the winter and the dry heat this summer have stressed trees.

The article stated that it might appear that some of the trees are "goners" (dying) but some species drop their leaves to survive dry spells and recover with rain. The article stated Post Oaks are especially finicky and hard to re-establish after being stressed.

Tree trimmers are scheduled in our neighborhood in November for another round of trimming. The Landscape Committee is happy to announce that newly-appointed Board Member John Murphy has been designated as our board representative. Thank you Eric Tourellis for helping out the past couple of months.

# MUD 136 Report

At its September meeting, the Board reviewed the District's water and sewer operations during the previous month. The Directors also discussed the fee increase that the West Harris County Regional Water Authority (WHCRWA) charges for the water it delivers to us. This fee is shown on your water bill next to the words "Regional Water Authority. This year it has been \$3.10/1000 gal. For 2019, it will be \$3.35. The fee has been increasing annually since 2008, when it started out at \$1.25/1000 gal. Revenue from the fee goes toward retiring the bonds used to build the 36 inch pipeline that delivers water to Deerfield. It is also being used to finance the new 96 inch pipeline that will serve western Harris County. The new line will run through Deerfield parallel to the existing 36" line in the pipeline easement. On October 25, WHCRWA will conduct a forum during which information will be provided about the status of the pipeline project.

## Financial Services Committee

Meetings are normally on the 3rd Tuesday of the month at 7:00 PM to review the financial status of our community. The next meeting date is **Tuesday October 16 at 7:00 PM.**

A large part of the expense overage shown is due to the expense of the renovation and repair of the annex stairway, incurred last month. In addition, we experienced a growing year to date overages due to expenses being incurred earlier in the year than they were budgeted. We expect to make good most of this shortfall by the end of the year, and in any case we have more than sufficient income to cover it.

The YTD assessment collection rate is 97.7%. This is 0.2% less than the 2017 comparable rate.

2019 budget drafts have been received and reviewed by the Finance Committee and were submitted to the Board at their Sept. 24 meeting so that they can begin their review and approval process.

### 2019 Assessments

**The 2019 DVCA Assessment will be announced in late October or early November.**

**However, if you want to avoid a cash crunch in December/January, you can start prepaying your 2019 Assessment early. To do this, start sending in monthly amounts, say \$100.00 or whatever amount fits your budget. Make sure your Deerfield Village address appears on the check. Send payments to:**

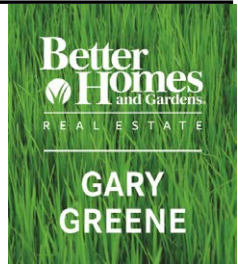
