## President's Report

Greetings Deerfield Residents,

I hope everyone received the 2019 Directory in February, which was placed on everyone's door. If you did not receive one, please contact the office, where you can pick one up, or ask us to send one out.

I received several emails and calls in February about our new trash and recycling vendor, Texas Pride, which has not performed to our expectations in the first month of service. MUD is aware of the complaints and very disappointed with Texas Pride's performance. I attended the monthly meeting, and they put the company on notice, that this performance will not be tolerated, and further issues will result in pursuing cause for termination. I spoke for a few minutes with the vendor to let them know of my disappointment and the complaints I received from residents. We were promised by the representative that all issues, including communication will be resolved immediately.

There is a special meeting on March 4th at 7PM, for the Board to discuss the Swim at your own Risk program for residents that are interested in participating. This is in review at this meeting. There will be an opportunity to ask questions under resident inquires.

The Annual Meeting of the Members and the Annual Meeting of the Board has been moved to Tuesday April 9th at 7PM in the Clubhouse. The new Trustees will be announced, and you will hear the financial state of the Association and 2019 goals. Please make certain that the grass/yard clippings along curbs are bagged. In case of a heavy rain, these clippings will be swept into the sewer system and block the runoff water; which in turn will flood our streets.

#### **Residential Trash Reminders**

As of February 1st, Deerfield Village has a new service provider, Texas Pride. Old recycle bins were picked up on January 25th, and subsequently new recycle bins were distributed to each household. ## Security Committee

We continue to have reports of criminal activity at night on our streets with cars driving slowly and checking out houses and also checking and removing mail from the mailbox. Remember if you see something like this, call SEAL and have them investigate. If you are the victim of a crime, please call HCSO and report it. That way they are aware of what is happening in Deerfield.

Just as a reminder, if you see something suspicious or criminal happening:

- If you feel in danger personally, call HCSO first and then SEAL if you can
- If you do not feel in imminent danger, call SEAL to help you out

We hope you read the article on parking last month. We've requested it be included in this month's Newsletter as well. There continues to be a lot of parking violations and we'd ask you to understand and follow the law. If HCSO comes through and enforces the law, there will be many unhappy residents.

## **Community Service** Committee

Deerfield is a great place to live, whether you are raising kids, working, or enjoying retired life. The neighborhood has gone through cycles of family demographics over the last several decades, and like any mature neighborhood, requires work to keep it attractive and pleasant. Reading Nextdoor, there is no shortage of people who have criticisms of how neighborhood issues are handled. It is surprising that more of those people aren't willing to invest a few hours a month to help deal with these issues. The Community Services Committee meets the first Monday of each month at 7 pm at the Rec Center. We deal with diverse issues, including maintenance and upkeep of the Rec Center facilities, pest control, greenbelt and Patio Homes lighting, and, most recently, the deteriorating condition of some of



the cluster mailboxes in the neighborhood. Do you have any concern about any of these issues?

#### PARKING LAWS IN DEERFIELD VILLAGE

Listed below are the parking laws that apply for Deerfield Village. If not followed, law enforcement (HCSO) can ticket you. Please abide by them.

You are not allowed to park or stand your vehicle:

- In front of a public or private driveway
- Within 30 feet of a stop sign, yield sign or other traffic
- Within 20 feet of a crosswalk or intersection.
- Within 15 feet of a fire hydrant
- If your vehicle obstructs another's driveway
- In a driveway if the vehicle extends into the street
- Double parked on the road side of another legally parked vehicle

Parallel parking is required on the streets of Deerfield Village. This means you must:

- Park WITH the direction of the traffic
- With both right-hand wheels parallel to and within 18 inches from the right hand curb

Straight in or angled parking in the cul-de-sacs is not allowed

You are not allowed to park on the street for over 72 hours on the street. If you do:

- A violation sticker may be placed on your vehicle
- Your vehicle may be towed at your expense for the tow and storage

Commercial Vehicles and Trailers are not allowed to be parked for long periods during the day or overnight.

Your neighbors have the right to call HCSO if they see these not being followed. Please don't give them reason to do so.

These are for all of our safety. Children can be hit and killed by a car driving 25 miles per hour because the parked cars have blocked off the line of sight for the driver. Emergency equipment may not be able to get to the houses they need to get to, and lives and property could be lost.

Please be a courteous and considerate neighbor. Be safety conscious for both yourself and your neighbors.

## Financial Services Committee

Meetings are the 3rd Tuesday of the month at 7:00pm to review the financial status of our community. The next meeting will be **March 19, 2019** 

Financial status as of January 31, 2019

YTD expenses \$54,348 Annual Op. Budget \$739,687 YTD budget \$69,647 Annual Res. Budget \$66,701 Under/ (Over)/budget \$15,299

Favorable budget variance is caused by the timing of budget vs when the expense is incurred.

The YTD assessment collection rate is 79.5%. The collection rate is 1.1% better than the comparable 2018 rate..

Assessments unpaid as of February 1, have incurred the \$100.00 late fee. If unpaid at the end of February a Certified letter, which is required by law in order for the HOA to protect their interest, will be sent. The sending of the letter at cost \$57.80 will be added to the resident's balance.

## Swimming Pool Committee

The 2019 swim season is fast approaching, and the Swim Pool Committee has been busy preparing the pool area. The 2019 Pool Calendar is being finalized as this newsletter prints and will be published in April's newsletter, so be on the lookout. Just a reminder, residents must have a Deerfield pool picture ID on file in order to use the pool. Pool IDs will be maintained at the pool during the season.

If you are new to Deerfield and have not yet had your picture taken for your pool ID, you can stop by the office beginning April 1st, Monday-Friday, 9:30 am – 1:30 pm. Special arrangements can be made if you are unable to stop by the office during these times. Just a reminder, assessment accounts must be current to have a valid 2019 swim pool ID tag. If you lease your house, you will need to have a valid release form completed and on file to have an ID to use the DV pool. Current IDs on file will be validated with a 2019 sticker, so you do not have to renew your ID every year.

The Swim Pool Committee (SPC) meets on the second Tuesday of each month. Next meeting is Tuesday, March 12, 2019. All meetings are held in the Annex and begin promptly at 7 pm. We would love for you to join us and get involved!



# **MUD 136 Report**

At its February meeting, the Board reviewed the District's operations during the previous month,

Including the trash and recycling collection. The meeting was attended by Deerfield residents and a representative from Texas Pride Disposal. Initial startup problems were discussed, with a particular emphasis on the lack of communication. The representative assured us that corrective action would be taken and the problems will not reoccur. We have requested that a representative be at our March meeting.

The new contract brings with it some important changes. Concierge service has been added. Styrofoam is no longer accepted. Branches from tree or shrub trimming cannot exceed 3ft in length or 6 inches in diameter. They can be left curbside bundled or unbundled. Bundles cannot exceed 3ft x 3ft x 3ft in dimension and cannot weigh more than 40 lbs., limit 8 bundles. Carpeting limited to 4ft wide tied bundles weighing less than 40 lbs. each, maximum 8 bundles. Heavy trash pickup every service day, limit 2 items. If you are ever in doubt about what types of trash and recycling are accepted, log on to the District's web site (www.hcmud136.org) and click on MUD SERVICES. The service day deadline has not changed. All trash and recycling is to be at curbside by 7AM on collection day. However, no trash before its time. DVCA rules apply to how soon the trash can be put out. The requirements in both the DVCA rules and the trash service contract are meant to minimize the effect that curbside collection has on the appearance of our neighborhoods. Your continued cooperation in following these requirements is very much appreciated. .

If you wish to comment on any of the District's activities, plan to attend the next District meeting, which will be held on Thursday, March 14, at the Rec Center beginning at 6PM.

## **Tennis Committee**

The project to replace 3 old lighting poles on Courts 3 and 4 is expected to take place sometime during March. It is expected that the work will take about a week to complete during which time these 2 courts will be closed for safety reasons.

#### **DVCA 2019 Election Process**

Deerfield Village Homeowners,

There are a few changes to our annual Trustee election, driven by both changes to applicable state laws and our own DVCA policies and procedures.

#### For the 2019 DVCA Trustee election:

- Votes can only be cast in person, in the Deerfield Village office by either the homeowner or their proxy.
- Votes can only be cast from 9:30 AM thru 1:30 PM on Tuesday, March 26, 2019 through Friday, March 29, 2019, Thursday, March 28, 2019 4:30 PM through 7:30 PM and on Saturday, March 30, 2019 from 10:00 AM until 2:00 PM.
- Bring a valid photo ID for verification of voting eligibility. (Applies to both homeowner or proxy
- Only one ballot per lot owned.
- Write-in candidates are permitted.
- Vote by Proxy is permitted. A Proxy must be in writing, specific to a lot, valid for the term
  of the 2019 DVCA Trustee election, notarized, and submitted at the time of verification of
  voting eligibility. The DVCA Office Manager will maintain a file of Proxy designations. A
  sample proxy form is included below. Please use it for your proxies. Please note that the
  proxy is required to be notarized or it will not be valid. If voting by proxy, it is highly
  suggested that the form be completed prior to the election due to the requirement that it
  be notarized.
- Ballots received by mail, email, fax or dropped into the lockbox (outside of the DVCA office) will <u>NOT</u> be counted.

#### **The Voting Process:**

- 1. Appear in the Deerfield Village office during the times for the 2019 DVCA Trustee election.
- 2. Present a valid photo ID for verification of voting eligibility.
- 3. After verification, receive an official 2019 DVCA Trustee ballot and envelope.
- 4. Cast a single vote for up to three positions. (No multiple votes for a single candidate. Total of votes for identified candidates plus write-ins not to exceed 3.)
- 5. Place the completed ballot in the envelope.
- 6. Seal the envelope and write the applicable lot address across the seal. (Ballots in envelopes without a written address will not be counted.)
- 7. Place the sealed envelope with written address in the ballot box.


## **Recreation Committee**

## **Landscape Committee**

Stay strong, Deerfield Villagers. After an apparently endless gray, rainy winter, spring will be here soon. The azaleas and oak trees are looking hopeful, even if the cautious pecan trees are still unconvinced.

We would like to thank, Jay Singleton, Landscape Committee Member, for all his efforts making the Deerfield Village landscape a source of pride for residents. Jay has managed the tree trimming and emergency fallen-limb clean-up for all our green space. We can thank Jay for sidewalk and sink hole repair, with the help of TMG. He has also been key in electronics recycling and document shredding with MUD 136. Jay has ensured that recycling bins on the greenbelt and other common areas are emptied. That is true community service. THANK YOU JAY!

Bags in dispensers have been placed at points on the Greenbelt and in the Patio Homes area thanks to Fred Ridenour and The Men's Group(TMG). Cleaning up your dog poop is the neighborly and sanitary thing to do. The situation has noticeably improved with dog owners using the bags from current stations. Everybody, not just dog owners, please help by contributing empty plastic grocery and bread bags to the poop station containers. These bags are easy for the dog owner to use if they are placed in the containers separately. It sounds like a small thing to contribute, but a convenient bag would be a big help to a busy dog walker.

#### March Landscaping Tips

- Trim and shape hedges to a desired size before the growing season starts.
- 2.Clean out and pull weeds from flower beds. The more weeds you clear now, the less weeding will be necessary later in the year if you mulch also.
- 3.Prune roses to 2/3 third of their height, to remove spindly growth and fortify structure; not lower than a 5 leaf cluster. Remove dead canes. A desired, uniform shape can be established at this time for all the roses. The roses can be fertilized at this time with rose fertilizer.
- 4. Wait on pruning and fertilizing spirea, azaleas, redbuds and oriental magnolias until after flowers have been spent.
- 5. Now is a good time to plant trees and shrubs.
- 6. When mulching around trees don't make volcanos, mulch no more than a couple of inches
- 7. Be on alert for that last hard freeze and cover those delicate plants

Spring seems to be here early this year and that means things are already growing, especially the weeds. So the slower growth period for our yards is over. Please start your regular yard maintenance to keep the lawns mowed and edged and the beds weeded. Randy Lemmons, host of Garden Line, said on February 24 that it is now safe to do anything that needs to be done in your yard. So we all need to get at it!

You should have received our spring clean-up letter and hopefully have started your plan to spruce things up. In April we will start sending violation notices for those things you don't take care of proactively. As previously stated, mold and mildew has hit us hard this year, so make sure you get that taken care of by the end of March.

If you have a lawn that looks like more roots and dirt, please look at the pictures we provided that show options other than lawns you can consider. They include rock gardens, monkey grass, jasmine, ivy, and ferns and can be found on the Deeds Tab of the DVCA website. Mulch and other ground covers are also options. If you have a yard that is in decline, now is the right time to take care of it.

We've had a rough start with the new waste management vendor that picks up the trash, making it more important to pick up your trash cans and recycle bins after they are emptied. Also, after a couple of months where trash bags being placed on the street early decreased, the problem is on the rise again. Trash is not allowed to be placed on the street until the evening before our trash pickup days (Tuesday and Friday). Another item we are seeing more of is parking off the edge of the driveway which creates ruts of dirt and mud. Please repair these ruts and stop doing this or extend your driveway (this requires an AA being approved) so it is no longer an issue.

She keeps a log with a photo, breed, pet's name, and your address, and phone contact numbers. A rabies tag is a great ID, but many Vets are not contactable 24/7 and the finder may not able to keep your pet for several days.
- If you are going out of town and have a pet sitter, let Marie know your pets name, what it looks like (a picture is also great), and a contact number.


