- B. **Instructions for Delivery of Completed Ballot:** A completed Ballot may be cast by submitting the completed Ballot to the Association's Office in person (at 4045 Deerfield Village Drive, Houston, TX 77084), scheduled for **9:30 a.m. until 1:30 p.m. on each of the following days: Tuesday, March 3, 2020 through Friday, March 6, 2020 and Saturday, March 7, 2020 from 10:00 a.m. until 2:00 p.m.** **Ballots not received in person, i.e. by mail, another person or dropped into the lockbox (outside the DVCA office) must have a valid contact email or phone number on form for verification, or they will not be counted.** All ballots must be received by **2PM, March 7, 2020.**
