MINUTES OF REGULAR BOARD MEETING September 26, 2016

The regular meeting of the Board of Trustees of the Deerfield Village Community Association was held at 4045 Deerfield Village Drive in Houston, Texas 77084. President Eric Toureilles called the meeting to order at 7:00pm.

I. DETERMINATION OF A QUORUM

President Eric Toureilles determined there was a quorum.

III. RESIDENTIAL INQUIRIES

A resident (not present at this meeting) requested that all front lots in Deerfield Village be treated for mosquitoes. Eric Toureilles reported that this request was made along with a request of financial records for review. Resident has heard this service had been previously provided, which it has not. A quote was also sought to know the cost of this service, which came in at \$800,000 for 4 months of treatment, which would be an increase of approximately \$800 per household. The Board has no intention of pursuing this further. Another resident reported that the mosquito truck has been passing through the neighborhood too quickly and is not adequately covering all streets, and skipping some. The Board said that this will be addressed with the contractor and rectified.

There have recently been some graffiti reported in the neighborhood and it is being addressed.
