



Tree Maintenance

On the common grounds of Deerfield there are trees that range in age from less than one year to more than 40 years. The oldest trees are in the Rec Center area and in the patio home common areas. It is the responsibility of the Landscape Committee to maintain the healthy trees and to remove those that are in decline or are a threat to safety or property. Since it costs a \$1000/day for a tree service crew, the Committee makes sure that there is a full day of work before calling out a crew. The crew will be directed first to removing trees that are dead, in decline, or whose roots are causing problems for property owners. Next in priority is the trimming of limbs overhanging private property and, after that, limbs overhanging streets and walkways. Last on priority is the thinning and shaping of trees.

To effectively run a tree maintenance program, the Landscape Committee needs volunteers to continually monitor the condition of the trees. This is an excellent opportunity to get some healthy exercise while performing a valuable community service. Please consider volunteering.

The <u>Audit Report</u> for the period ending March 31, 2005 is almost complete. Due to some new audit reporting changes, the board postponed approving the audit results until the September meeting. After approval, the report will be posted to the District's website. The <u>Tax Assessor and Collector's report</u> was presented and reviewed by the board. At this time the District has collect 98.63% of its 2004 taxes. If you still owe taxes for 2004 or previous years please try and pay them soon as penalties and fees are being added.

The Operations Report had the normal maintenance and operations items as well as some non-recurring items. After the normal business was finished the Board moved the meeting to the well site so that everyone could get a good idea of what was being considered.

In the Engineers Report the subject of water well #2 was discussed. The well is showing small traces of brass which denotes wear beginning to take its toll on the down hole pump. The consensus of the Board is to perform well production tests at regularly scheduled intervals to monitor any significant change that might require an overhaul. The engineer also reported that the utility tie-in at Stacy Plaza was completed and that all inspection issues had been corrected. The Board accepted his recommendation and voted to accept the facilities into the District.

In the May newsletter it was reported that construction of the major pipelines that will supply this entire area is in progress. Originally our area was not scheduled for surface water conversion until after 2010 but design, approval and construction for our area is now scheduled to start in early 2007 with construction to be completed by early 2009. While our own connection is not due until 2009, the interconnections between MUD 136, Windsong MUD 183 and MUD 6 the new subdivision across Windsong Trail might require conversion to a chloramines system at an earlier date. The Board will continue to follow up and report as we get closer to these dates.

We will be reporting anything that concerns this district at the meetings and in the newsletter.
