

Keighborhood Watch Brogram

The Security Committee has installed important information related to the Neighborhood Watch Program on the Deerfield Village Website, (www.deerfieldvillage.net). The Neighborhood Watch program contains information that can help keep your home and family safe and secure. There is a section that lists all the block captains and section leaders and maps showing where each block is located. A Crime Watch information-reporting sheet is included. This sheet can be used when reporting or receiving information on suspicious or criminal activity. It is very important that correct information be recorded and passed on regarding any incident that has occurred.

The Security Committee is asking everyone to go to this website and look up your street. Please check the maps and list to see if your street has a block captain. If your street does not have a block captain, please consider becoming one. If your name is listed as a block captain or section leader and you no longer want to serve in that capacity, please contact the Security Committee. The responsibilities are:

<u>Block Captains</u>—Goal is to have at least one block captain per street block.

Responsibilities

- 1. To contact each neighbor on his or her assigned street and complete a "Neighborhood Watch" form, including names, phone numbers, vehicle descriptions, license plates, children, etc.
- 2. To inform block neighbors of any security activities that has been passed down from the section leader.
- To receive reports of security-related activities from block neighbors and relate that information to their section leader.

All Section Leaders and Block Captains are members of and are encouraged to attend the Deerfield Village Security Committee meetings that are held on the second Tuesday of each month at the Deerfield Village Recreation Center at 7:30PM; however, attendance is not mandatory.

The Board received the resume of Jim Hewlett for the position of replacement director. The board voted and approved his appointment and he will fill the term that is to expire in May 2008.

The Board also voted and approved an Order Calling for Director Elections. This is the election in May to fill the expiring terms of directors Steve Dornak, Barry Greer and Jay Singleton. Each of these directors has stated they do plan to run for reelection. Candidates for election must apply for an application to Fulbright & Jaworski L.L.P., Attn: Jana Cogburn, 1301 Mc Kinney, Suite 5100, Houston, TX 77010-5246. The application must be returned by March 13, 2006 for their name to appear on the ballot. The election will take place on May 13, 2006.

The Board will also start work on the budget for the next fiscal year at the February meeting.

The Tax Assessor and Collector's report was presented and reviewed by the board. The District has collected 99.07% of its 2004 taxes and 65.56% of 2005 taxes. Ms Rodriguez stated that the 2005 collections were running behind last year in part due to delays in mailing some of the tax bills, a delay caused by late property value certifications from the Appraisal District. Homeowners should have received the 2005 Tax Statement by this time. If you or your mortgage company have not received it by now please call Bob Leared Interests at 713-932-9011. MUD #136 taxes are due January 31, 2006 and after this date penalties and interest begin to accrue.

The Board voted unanimously to authorize a tax exemption of \$15,000 of the appraised value of residence homesteads within the District for individuals who are disabled or are 65 years of age or older.

The Board also discussed alternate forms of water bill payment. The additional fees to the district (previously in the plan) have been waived. The attorney confirmed that the language used in the agreement is standard wording that is included in other contracts that ECO has with other districts. The Board will consider action on this item next month.

Mr. Eckert of ECO Resources and Mr. Troutt of TC&B presented the Board a report of the panel failure at water plant. They explained their findings and felt that the electricity provider was not at fault. The problem turned out to be the welding together of the starter contacts, causing the starter to short. This type of failure is rare and should not be a problem in the future as the replacement controls use solid state equipment, eliminating the starter contacts. The Board also approved a new lightning arrestor recommended by Mr. Trout for additional protection.

The next HCMUD 136 meeting is **Thursday, February 9, 2006 at 6:30 pm** in the Deerfield Village Recreation center. Meetings are open to the public and you are encouraged to attend.

New cards are mailed to all current registered voters, but they <u>will not be forwarded</u> if you have moved.

If you are not currently registered and want to vote in the March 7 Primary, you must be registered by February 6. Registering to vote is easy! Get an application card from the Voter Registrar's office, the Clay Road Courthouse, the DVCA office, or give me a call at 281-855-7716. Fill it out and mail it in. It's that easy!


All About Mulch

Because of warmer than usual temperatures, the spring growing season has already started. So, it's time to start sprinkling the trees and plant beds. But, because Mother Nature is being stingy with her rain and the Regional Water Authority has raised its water pumpage fee, it's also time to be water smart.

Conserve the water you have sprinkled by

using mulch, but not more than 3 inches deep. Anything more will create a blanket too thick for water to penetrate. Mulch not only keeps the moisture in the soil from evaporating, it also protects the soil from heat by either reflecting the heat (light colored mulch) or absorbing

~No building or improvements or changes in design on any lot until plans and specifications have been submitted and approved. (This includes but is not limited to new roofs, pool installations, house additions, new siding, exterior painting, patio additions, etc.) ~Maintain all structures, including fences, in safe and attractive condition. ~No structure may be placed on utility easements. ~No business activity, for profit or not, shall be permitted. ~No noxious or offensive activity of any sort, nor shall anything be done on any lot which may be or become an annoyance or nuisance to the neighborhood.

Collection Event Harris County Annex 13 & Sport Complex—17423 Katy Freeway (Enter via Barker-Cypress) 8 AM to 2 PM only

Harris County holds approximately ten (10) one-day drop-off events for Household Hazardous Waste throughout Harris County each year. The events are typically held during the spring and fall season, and are free to all residents of Harris County. **The upcoming date is April 8.**

Residents may bring household quantities of paint products, pesticides, fertilizers, motor oil, gasoline, pool chemicals, household cleaners, aerosols, batteries and automotive tires (5 per household).

Used electronics such as televisions, computers, word processors, printers, scanners, fax machines, cellular phones, VCRs, stereos and other small personal electronics are also accepted. Residents may bring up to five (5) of each of these items.

A mercury thermometer exchange is also held in conjunction with each of the events. Residents may bring a mercury fever thermometer for proper disposal and receive a FREE, non-toxic replacement.

Participants will receive information on less toxic alternatives to common hazardous household products and can also shop for FREE items at the reusable products booth located near the exit of the drop-off site!

Business waste, medical waste, ammunition, explosives, compressed gas cylinders, washers, dryers, refrigerators, freezers, air conditioners, photocopy machines, microwaves, or smoke detectors are NOT accepted at these events. Businesses may call the Texas Commission on Environmental Quality (TCEQ) Small Business and Local Government Assistance Hotline (800-447-2827) for information on proper disposal methods for hazardous waste. The hotline offers free, confidential technical assistance.
