- Long discussion about mosquito control occurred.
 - Committee does not support mosquito spraying.
 - O Glenn covered a brief history of mosquito control: stopped in 2006 with no public notification. Presently he does not want the Board to override the Committee, but advocates the need for a forum for residents to be informed and make their interests known, keeping in mind that the budget deadline is October. He asked for ideas
 - o Peter Howell gave a report on his work on Mosquito control
 - Stated that there is no data on the effectiveness of spraying.
 - The County comes to spray where there is a significant problem. We are in the West Nile focus area for the county.
 - Cost of 3 proposals range from \$3000-6200. The higher bid includes spraying, fogging and tablets in drains.
 - Andrew Jackson inquired how to resolve this issue of overturning the Community Services decision.
 - Carolyn Dinger motioned to begin a two month trial (August and September) of mosquito control of Premier fogging that will include a weekly spraying, fogging and tablets not to exceed \$3500 for the 2 months. Bohn 2nd. Motion carried 6-1-1. Bob Henry opposed, Glenn Sommers abstained.
 - Peter Howell will communicate and provide forums for the members in Aug. and Sept.
