President's Report...

Dear Neighbors,

I hope that everyone had a great Thanksgiving with family and friends. As we go into the holiday season again, I'm looking forward to seeing the impressive displays of lights and decorations by the residents that have the courage to do it!

At the November Board meeting, the Trustees reviewed and approved the budget for 2012. I appreciate the hard work by the Financial Services Committee in putting this together and the other Committees that worked hard to tighten their belt, while keeping our commitments to the community. Although costs have gone up, including utilities, we have managed to keep the increase just above 2%.

In regards to this year's homeowner Assessment, we made an increase of \$12 per home to support our expenses. We are very fortunate that our Association is made up of volunteers, which allow us to enjoy a reasonable yearly Assessment, in comparison to the amenities and activities offered in Deerfield. Overall, we are financially solid and our commitment and passion in keeping Deerfield a safe, beautiful and fun community to live is very strong.

Please note that the Board will not meet in December, but we will meet on January 23, 2012. We will be available for regular business throughout December; however, the DVCA office will be closed on

Monday December 26th.

To be in compliance with upcoming 2012 laws, the upcoming 2012 elections will change. A property owner will need to



print a ballot form from our website or pickup a ballot form from the office, and voting will be either in person, by email or fax, by USPS mail (received before the closing of the elections) or by Proxy. The election will be during the last week of February, closing on March 3rd. Ballot forms will be available in January 2012.

We continue with the Coffee and Donuts on Friday's, at 8:00AM. We will not have them on Dec. 23rd or 30th


because of the Christmas Holidays. Come by and have a donut, tea, or hot chocolate, and learn what's happening...

MUD 136 Board Report...

At its November meeting, the Board reviewed the District's operations during the previous month. In October, the District delivered 17,800,000 gallons of water, a 25% reduction from September. Since that usage is closer to normal for this time of year, we have lifted the watering restrictions and removed the alert signs.

However, the need for water conservation has not gone away. The current drought is expected to extend well into Spring and the annual pattern of lower than normal rainfall is expected to last for the rest of this decade. For more information, log on to www.whcrwa.com/index.html. There you will find a slide presentation by the meteorologist for the Harris County Flood Control District given at a town hall meeting. It explains just how grim the outlook is.

Another bit of bad news is that the cost of water will be going up. Effective January 1, 2012, the West Harris County Regional Water Authority (WHCRWA), which sells us the water we use, is raising their fee from \$1.85 to \$2.10 per 1000 gallons. That cost will first be reflected in your February bill next to the words "Regional Water Authority".

A great way to offset that cost increase is to conserve more water. The website

www.wateruseitwisely.com offers many useful tips for doing this. If you have any other suggestions for reducing water consumption, please submit your ideas to any of the Direc-

tion, please submit your ideas to any of the Directors. If you wish to offer your ideas in person or to comment on any of the District's activities, come to the next District meeting, which will be held on Thursday, December 15, at the Rec Center beginning at 6PM.

Expenditures: Expenses continue to come in below budget with income above budget. The combination of both will give DVCA a larger surplus then originally forecasted.

Assessments: We have collected \$640,696(97.64%) of the 2011 assessments. Collection rate remains slightly ahead of the 2010 rate.

2012 Budget: Budget for 2012 has been finalized and will be presented to the Board for approval.
