# MINUTES OF REGULAR BOARD MEETING January 23, 2012

#### IV. PRESIDENT'S REPORT

Eric Toureilles reported that over the holiday the Board Approved the painting of the Rec. Center. The painting has been completed. The approved policies have been submitted to the county. A resident reported that they fell on what was described as a hazardous condition on the green belt sidewalk. After walking the area no obvious hazard was seen. Troop 120 has been invited to attend the next board meeting to give their annual report. There were a couple of incidents that occurred in the neighborhood over the holiday. There was a domestic dispute on Widcombe that resulted in a homicide. The second domestic incident was on Longcliff which ended in a suicide.

#### V. TREASURER'S REPORT

We begin the New Year financially sound. We ended the year with a Assessments collection rate of 97.7%. On an unaudited cash basis, we going to generate an excess \$80K-\$90K from budget savings and the recommendation are that money goes into the reserves for the streets and contingency fund. The last year ended with 13 residents owing some portion of their 2011 assessments, which is a reduction from the previous year.

#### VI. MANAGER'S REPORT

The Office Manager reported all of the new policies have been filed with the County. The process has begun the change the website to include the new information and reorganize the information to make it easier to access. Eric Toureilles asked how much revenue was lost during the time the Rec. Center was closed for painting. The manager reported two rentals were lost totaling \$150.

#### VII. STANDING COMMITTEES

#### A. Finance Committee

A proposal was submitted by the CPA that did the Audit last year to provide an Review and tax return for this year. Amy Lacy motioned to approve the proposal. The motion was seconded by Brent Burris. The motion passed unanimously.

# B. Deeds Committee

An Election was held for the 2012 Officers of the Deeds Committee. Jeff Youngflesh was voted in as Chair, Samantha Lacewell as Vice Chair, and Fran Jolly as secretary. Eric Toureilles motioned to approve the persons elected to the Deeds Committee. The motion was seconded by Brent Burris. The motion passed unanimously. The Deeds Committee By-Laws have not been modified in several years and this year they will be reviewed, and any recommended changes will be submitted for approval. The committee brought up a discussion about a fund for means that people could donate to help residents in need. The details on how to manage the fund and if DVCA can be participate in this program will be discussed with our Attorney.
