
Dear Neighbors,




Residential Trash Reminders...

Pick-up days are Tuesday and Friday. **Please** do not put your trash out until Monday evening or Thursday evening.

Nothing but water should go down our storm drains.

Please make certain that the grass/yard clippings along curbs are bagged. In case of a



heavy rain, these clippings will be swept into the sewer system and block the runoff water; which in turn will flood our streets.

MUD 136 Board Report...

At its December meeting, the Board reviewed the District's operations during the previous month. On December 3, the Directors did an inspection tour of the water plant and sewer lift stations and concluded that, other than for a few minor repairs items, the facilities are in excellent condition. Also included in the tour was a visit to the West Harris County Regional Water Authority (WHCRWA) pumping station on Hwy 529, just east of Eldridge Rd. This plant receives from Houston and delivers to the Authority's utility districts over 30 million gallons of water per day. But, only 30% of the Region is on surface water. By 2020, state law requires 70% of the districts to have converted from well to surface water. To meet that hugh increase in demand, the Authority will construct a new 8 ft diameter pipeline, which, like the current line, will run through Deerfield. For inabout the new line, log www.whcrwa.com/index.html. To pay for construction of the pipeline distribution network, WHCRWA has is-

sued revenue bonds. To pay the bond interest, they levy a fee on the water supplied to each district. Effective January 1, 2012 that fee will increase from \$1.85 to \$2.10 per 1000 gallons. That fee increase will first appear in your February bill next to the words "Regional Water Authority". The Authority has increased its fee annually for the past several years and there is no reason to doubt that they will continue to do so. In another bit of bad news, experts predict that the current drought conditions will continue at least through Spring. A great way to offset the fee increase and deal with the continuing drought is to conserve more water. The website www.wateruseitwisely.com offers manly useful tips for doing this. If you have any other suggestions for reducing water consumption, please submit your ideas to any of the Directors. If you wish to offer your ideas in person or to comment on any of the District's activities, come to the next District meeting, which will be held on Thursday, January 12 at the Rec Center beginning at 6PM. I then called the "chip" company and they advised me that the "chip" may have gone dead or had "traveled" to another part of the animal's body.

After taking the dog to get a new "chip" at Farm and Ranch Free Chipping last month - and scanning her whole body - it was determined that the chip had indeed traveled to the side of her upper right leg. Every time you visit the vet, have them scan the whole body for that "chip".

FILING FOR HOMESTEAD EXEMPTION: NEW RULES FOR 2012

For all New homeowners in Deerfield Village that want to file for the Homestead Property Tax Exemption in 2012, there are more rules to follow. In Sept. of 2011, the State Legislators made having the new address on your Driver's License or State ID and on your Vehicle Registration a requirement and you have to send in the receipts for the changes along with the exemption request. You can file between Jan. 1, 2012 through April 30, 2012, for the exemption, but getting these receipts takes time, so don't delay.
