

The 2012 Annual Election of Trustees shall take place at the Deerfield Village Community Association Office, 4045 Deerfield Village Drive, Houston, Texas 77084, between 9:30 a.m. and 1:30 p. m. on Tuesday, February 28, 2012 through Saturday, March 3, 2012, inclusive, and votes will be tabulated after 1:30 p.m. on March 3, 2012. The Trustees elected to the three (3) expiring positions will thereafter be announced and seated at the 2012 Annual Meeting of the Members of Deerfield Village Community Association, Inc. (the "Association") scheduled to commence at 7:00 p. m. on Tuesday, March 3, 2012, at the Association's Office.

Due to Texas statutory law, secret written ballots are no longer allowed and proxy voting must be allowed.

In order to be valid, electronic ballots need to be completed, signed, dated and emailed to deerfield4@sbcglobal.net or faxed to 281-463-7679 so that they are received by the Association no later than 1:30 p.m. on Saturday, March 3, 2012. Mailed Ballots must also be completed, signed, mailed and received by the Association no later than 1:30 p.m. on Saturday, March 3, 2012. Any Ballots received by the Association after 1:30 p. m. on March 3, 2012 will be void.

All Owners are allowed to vote. The Candidate receiving the highest number of ballots for each of the three (3) Trustee positions is elected. Each Trustee elected shall serve for a term of three (3) years.

MUD 136 Board Report...

At its January meeting, the Board reviewed the District's operations during the previous month. The Directors voted unanimously to continue the exemption for those who are over 65 or permanently disabled. The amount, \$20,000, will be applied to the 2011 assessed value of a qualified homeowner's residence. The 2011 tax rolls are complete and the total value for Deerfield is \$185.3 million. In 2010 it was \$187.4 million. The all time high was \$196.5 million in 2008.

January 31 was the last day to pay the MUD property tax without any penalty (6%) or interest charge (1%/mo). If you have not received your tax bill or have a tax question, contact the District's tax collector, Bob Leared Interests, 713-932-9011. You can also get information from their web site, www.bli-tax.com.

For those of you who do on-line banking, please note that your monthly bill has a new account num-

ber. Also note that your garbage pickup charge is not stated separately. It is part of the sewer charge.

Be aware too that, if the beginning reading of your water meter is significantly different from your previous months closing reading, it means that your meter has been replaced. Metes are changed out when they have registered 1 million gallons, which is their average life expectancy.

Have you noticed the blue and green paint marks on the curbs in Deerfield? As part of our valve and manhole survey, we are marking the location of water control valves with blue paint and the sewer manhole locations with green. We are also continuing to televise the sewer lines and make repairs as necessary to insure that our system remains in good operating condition.

If you wish to question or to comment on any of the District's activities, come to the next District meeting, which will be held on Thursday, February 9 at the Rec Center beginning at 6PM.

Unfortunately we've lost some of our big trees. We've been working on removing dead trees and grinding the stumps. We're watching some possible dead looking trees to see if they're still alive this spring.
