Please be advised that the Board will be approving a Towing policy in January for the Patio Home area, as those are Deerfield private streets. Although the Protective covenants allow us to enforce this, by law we are required to post a sign and the number of the towing company, as a non resident would not be familiar with these rules. We will have more information in the February newsletter to keep everyone in the loop.

It has come to my attention from a resident that we had a burglary on Spruce Creek, and we had not reported it via DVCA email blast. We are working with Law Enforcement to be sure that this type of information is reported to the DVCA office and the Security Committee, so we may distribute it timely

Nothing but water should go down our storm drains.



MUD 136 Board Report...

Among your holiday gifts was there a new electronic gizmo to replace your old one? If so, hang on to the old one until our special recycling event in April. Details to follow.

At its December meeting, the Board reviewed the District's operations during the previous month. On December 8, the Directors made an inspection tour of the water plant and concluded that, other than for a few minor repairs items, the facilities are in excellent condition. The estimated replacement cost of the water plant facilities is \$2,900,000. The water plant, which is located behind Randall's, was constructed in 1975 (the District itself was formed in December, 1974). The plant has a water well capable of producing up to 1000 gallons/minute. The well serves as a back up source of water. The plant has facilities to treat the well water with disinfectant and fluoride. The plant also is connected to the West Harris County Regional Water Authority (WHCRWA) pipeline, from which the District receives treated surface water. During 2012, 1.5 MM gallons of water were produced by the well and 150

MM gallons were purchased from WHCRWA. The water is held in 2 storage tanks, one having a capacity of 650,000 gal. and the other 529,000. Water is distributed to residences through a series of underground pipes. To find the location of the water line on your street, look for the nearest fire hydrant. The District also provides water to Walgreens and Deerfield Park. Through interconnections with MUD 183 (Wind-song) and Barker Cypress MUD (Lakes of Pine Forest), each district can provide the others with water in an emergency situation. A series of electric pumps at the plant assure that there is constant water pressure. Should an electrical outage occur, a natural gas fired generator automatically kicks in to maintain power.

The District also has facilities to provide sewer services. That topic will be covered in next month's article. In the meantime, if you have questions or comments on any of the District's activities, come to the next District meeting, which will be held on Thursday, February 8 at the Rec Center beginning at 6PM. The Directors of MUD 136 wish you a most prosperous and water wise New Year.

Expenditures: Actual continues to be below budget. We will be under budget for the year.

Assessments: We have collected \$647,829(97.4%) of the 2012 assessments. We are slightly behind (.3%) last years collection rate.

2013 assessments not paid by 1/31/2013 will incur a \$100 late fee.

The following is a repeat from the October newsletter:

In January liens will be filed where only the 2012 balance is owned. To avoid \$157 in attorney and filing fees 2012 assessment plus late fees and interest for 2012 MUST BE paid by 12/31/2012. State law now requires HOA's to use an attorney to file the lien.

The 2013 budget process has been completed and approved by the DVCA Board. Thanks to the Committees controlling expenses assessments will remain the same as 2012's.


Pot Luck Supper



TIME TO FILE FOR HOMESTEAD EXEMPTION

The New Year is finally here and it is time for all the New Home Owners in Deerfield Village, to file for their Homestead Exemption with HCAD, the Harris County Appraisal District. It must be your primary residence in Texas to qualify and you must occupy it on Jan. 1, 2013. You must show your Driver's License Address is now the same as your new home and you must show your Vehicle Registration address is the same as the new home. If you don't drive, you must provide State-Issued ID and an Affidavit that you don't own a vehicle. For more info and the Latest Instructions, please call or email me, I'll be happy to send them on to you.
