Last, the resident commented that since switching to surface water an odd color and odor are present in the water. A notice was included in the last water bill noting contaminates in our water and that resident should be made aware of this. The board informed the resident that everyone, as required by law, receives the same notice and that it does not mean the water is unsafe, that in fact the opposite is true.

Another Resident brought up the subject of mosquito spraying. The Board reported that there has been some difficulty locating a service provider which is why there has not been any spraying. A contract is in negotiation and services will begin soon.
