President's Report

Greetings Deerfield Residents,

I want to thank those that attended the Annual Meeting of the Members, and the Annual Board Meeting. We had over 50+ people in attendance to hear the updates from the Committees and the Board, which is spectacular. We touched on several points, but I started out with a big thank you to all the volunteers that donate their time to our community, and the Association. This included the Men's Group, which we are very fortunate to have, and Troop 120, which gave their annual report, and the Deerfield Dolphins. Additionally, I thanked Doug Landry and Mark Klodzinski for their service on the Board.

I reported that the health of the Association is strong, and we have made many improvements in 2017/2018, and many more to come. Here are some important highlights: A) We continued to support our SEAL patrol, which has been well received by all, and covers Deerfield 24/7 as of 10/2017, and into the future. With our neighbors and SEAL watching for suspicious activity, you can see from the public Crime Reports website that Deerfield is not suffering from repeated crimes, as those around us. B) The Board will be focusing on reviewing policies and guidelines, to make sure we are in compliance with all local and federal laws, as well as simplifying language for all residents to understand, and create a healthy/friendly environment for all. C) In 2019 the County will begin a project on Windsong Trail by replacing the asphalt road with a concrete road with underground storm drains. The purpose is to address the concern we all have with the erosion on the west side of the road, and not to address flooding, as this area has not had an issue. However, this will help resolve the issues with the perimeter fence and utility poles that can become a danger as a result of the ground erosion. More to come on this, and I have also sent a letter to the County asking them to grant DVCA an

easement along the west side, to possibly support a future fence project, and a quote for a sidewalk. Although the Association is not in favor for paying for a sidewalk, there is no harm in asking for a cost, as there may be interest in the future by the Lakes of Pine Forest or DVCA or the school. E) I talked about the effects of Hurricane Harvey, which devastated so many areas around us, and how Deerfield supported our Community. We were the only HOA communicating on what was going on with flooding, water and the sanitary issue, (Thanks MUD #136 and Neil Polanski). We made a place for local law enforcement to have a place to plan rescues, eat and sleep. Many Deerfield residents made warm meals, gave officers a place to shower, and/or provided boats and other equipment to render aid. Brian Harris and his team of deputies, and other first responders were very appreciative that Deerfield opened their facilities to them, with no question and open arms. F) Last highlight, it was interesting to hear that the number one in volume Deeds infraction, was trash cans and lawn bags left for days at a time. It is certainly not the most important issue they are addressing, but it does show that we have many residents that may not know that there is a restriction that bags and cans should be placed the night before, and not on a Saturday, waiting for pickup on Tuesday morning. It's not fair to those following the rules, and perhaps we need to communicate better that this is not acceptable. We will work on that in 2018, or come up with some solution.

Keep Deerfield Bright at Night...

Please report Street Lights and Greenbelt Lights that are out to the DVCA Office; phone: 281-463-2624. It is necessary to provide the pole number and the location address of the pole that is being reported. Street Lights that are not on the Greenbelt and not in the Patio Home Section may be reported directly to Center-Point Energy at the following website:

http://www.centerpointenergy.com Click on the "Report a Streetlight Outage" located in the middle of the page. You can then click the "request form" and complete the requested information and submit.

Nothing but water should go down our storm drains.

Please make certain that the grass/yard clippings along curbs are bagged. In case of a heavy rain, these clippings will be swept into the sewer system and block the runoff water; which in turn will flood our streets.

Residential Trash Reminders

Please know that there is a 15 bag limit in regards to yard debris per service day. Anything over this limit must be negotiated between the home owner and Waste Corporation of America: 281-368-8397. Hours of operation are 7 am to 7 pm, office hours are 7 am to 4 pm. Pick-up days are Tuesday and Friday. Heavy trash day is Friday, limit 1 heavy item per service day per household. Please do not put your trash out until Monday or Thursday evening.

MUD 136 Report

At its March meeting, the Board reviewed the District's operations during the previous month.

In preparation for the District's new fiscal year, which runs from April 1, 2018 through March 31, 2019, the Directors adopted an operating budget. The most significant capital expenditure is replacement of the electrical control panel at the water plant, expected to cost \$300,000. The largest item in the Repair & Maintenance category is \$90,000 for maintenance of the water distribution system. Among the work items covered is replacement of water meters.

Residential water meters are changed out when they have registered 1 million gallons, which is their average life expectancy. On your monthly water bill, if the beginning meter reading is significantly different from the previous months closing reading, it means that your meter has been replaced. At every residence in Deerfield, the meter itself and the piping leading to it belong to the District. Everything after the meter belongs to the homeowner. You may have received a flyer in the mail from Houston Service Plans indicating that the homeowner's responsibility begins at the property line. While that may be true in other subdivisions, for Deerfield residences that is not correct. Ownership is determined by the location of the meter.

If you have questions about the new budget or any of the District's activities, come to the next District meeting, which will be held on Thursday, April 12, at the Rec Center beginning at 6PM.

Financial Services Committee

The YTD assessment collection rate is 91.4%. This is 0.4% better than the 2017 comparable rate.

Assessment invoices should have been received by 11/15/2017. If you still haven't received one by now, please contact Cheryl Beisert at Consolidate Management (281-296-9775 ext207) to request a copy.

Assessments were due by 12/31/2017 and are considered delinquent and subject to late fees after 1/31/2018. Assessments still unpaid (or without a signed payment plan) as of March 15 will incur an additional charge, for service fees and mailing expense, of at least \$57.60.

We are waiting to hear when the County will fix/replace the front entrance garden and will set up spring plantings as soon as we get a date. Thoughts from the committee are hosting a master gardener event and family flower plantings this year among other ideas.

We welcome all to join the Landscape Committee. If you are interested in joining our committee, we meet the second Monday of every month at 7 p.m. in the Clubhouse. Out next meeting is April 9 and again on May 14th.

Pet Hotline News

- Make sure your pet has a form of ID on their collar. Key tags are available 3 for \$2.00 at most hardware stores and work fine for pet ID's.
- Did you know that you can register your pet with Deerfield's Pet Hotline? Call Marie Nugent, 713-818-5799 for a Pet Hotline tag for your pet. The tag has Marie's home and cell phone number. She keeps a log with a photo, breed, pet's name, and your address, and phone contact numbers. A rabies tag is a great ID, but many Vets are not contactable 24/7 and the finder may not able to keep your pet for several days.
- If you have your pet microchipped, make sure you register on the database and keep your information current. Pets have been found wandering around the neighborhood and, when taken to the vet, found they were microchipped but the information was obsolete, thus making it harder to contact the owner.
- If you are going out of town and have a pet sitter, let Marie know your pets name, what it looks like (a picture is also great), and a contact number.
- And if you are thinking about owning a pet Ask yourself IF:
 - You have time to get its shots and check for heartworms
 - You have time to get a collar with ID and a phone number on the tag
 - You have time to walk it on a leash and PICK UP THE POOP.
 - You have the money, time and commitment to care for a pet.

IF you answer NO to any of these questions, maybe you should NOT get a pet.



You must be the homeowner, or have a release from the homeowner to obtain a card. The Access Cards also allow you to enter the restrooms and the Clubhouse and Annex when you rent the facilities. Old tennis keys can still be returned and a refund requested. We still have a number of old keys that have not been returned.

Architectural Applications must be submitted to the DVCA Deeds Committee prior to beginning any project. A copy of your plat or survey will be required for fences, pools, sheds, patio covers, etc.

To expedite the approval process for larger or unusual requests, please have your Architectural Applications to the DVCA office at least 1 week prior to the Deeds Meeting (the 1st Monday of each month).

Applications are, of course, accepted all month long.

Approval must be received in writing prior to beginning any project.

Thank you to all residents who comply with our Protective Covenants by submitting Architectural Applications when making changes to the exterior of their homes.

- DVCA continues to be a safe haven according to CrimeReports.com
- SEAL is doing very well and our residents are very favorable of SEAL
 - Seal handled about 840 calls in the last year, an average of 70 per month
 - SEAL continues to be very committed and responsive
 - Our SEAL officers have a great relationship with many of our residents
 - The Security Committee has an excellent relationship with SEAL
- The Sheriff (HCSO) is being very responsive to our calls for Law Enforcment
- Our residents continue to be vigilant in reporting suspicious activity
 - Accounting for almost 25% of the calls made to SEAL
- There were a very low number of significant issues in the last year
- The most common issues have been:
 - Unlocked vehicles in the driveway or on the street
 - Garage doors (overhead and entry) being left open
 - False alarms of home security systems
- CrimeReports.com continues to show that Credit Card and Identity Theft are an issue for our residents
- We also take care of the Video Surveillance System at the Rec Center and a have been able resolve this years' technical issues on our own

The Security Committee is stable and has a very good attendance of our members. We are always looking for more people who want to help keep Deerfield safe and will welcome anyone who wants to join! We meet at 7pm on the 1st Tuesday of the month and our next meetings will be on April 3rd and May 1st at 7pm. Hope to see there!
