# MINUTES OF REGULAR BOARD MEETING July 22, 2019

# I. <u>DETERMINATION OF A QUORUM</u> (6 required)

# G. Financial Services Committee

- a) Review of property discussed in June Discussion of multiple existing problem property issues and updates. Requests were made of the Deeds Committee to provide additional documentation / pictures for the August Board Meeting
- b) Deeds update Color sub-committee created and evaluating requests on a case by case basis. 75 properties in review and/or taking action.
- c) Discuss and vote on properties needing Board approval Votes were not taken due to lack of a quorum, but we discussions possible recommendations for the Deeds Committee.
