## MUD 136 Report

Harris County Municipal Utility District 136 Board of Director's monthly meeting was held, in person, on Thursday September 8, 2022 in the DVCA Recreation Center.

The Board reviewed water and sanitary sewer operations from the previous month with presentations from our consultants, continued our discussions pertaining to the long-term Assessment Management and Replacement Plan being prepared by our District's Engineer, trash and recycling services, in addition to other agenda items pertinent to our District.

The Board continues its review and consideration of the asset management proposal that our District Engineer has prepared. In place inspections should begin shortly on portions of the sanitary sewer system within our District as part of an overall plan to assess the condition of the lines needed to prepare our plan to address necessary maintenance issues. This will be a relatively long-term program that is expected to continue over the next five years. In addition, the rising costs of our contractors, materials and inflation has required the District to modify the Sewer Rate to an additional \$4/monthly.

On August 11 a subcontractor for AT&T installing fiber punched 2 4" holes through our 8" water main on Radworthy Dr at Bradstone Dr. Our operator, MOC, will begin repairs as soon as possible, this will require an open cut to the entire street. Bradstone Dr will be closed to all traffic, however this will expedite the total time for the repair and reduce the length of inconvenience.

During the meeting our District Financial Advisor presented recommendations for the 2022 Tax Levy. We voted to publish a tax rate of \$0.155 per \$100 of assessed valuation. The final tax rate will be presented and voted upon in our next meeting.

With drought conditions expanding over much of Texas, the Houston area has moved into the "moderate" to "severe" designation. MUD 136 is following the lead of WHCRWA for our drought status, at this time we remain in "Stage I" conditions. We expect this to change this month as conditions have been improving.

This year the shredding/paper recycling event will be on Saturday, October 22<sup>nd</sup>. The DVCA Men's Group has volunteered to run an e-Cycle event in conjunction with the District's annual Shredding Event. If you have household hazardous waste, please check with Harris County for drop locations.

As a reminder residents can sign up to be included in the MUD's text alert system by texting "hcmud136" (without quotation marks) to 74121, creating an account using an email address at https://mobile-text-alerts.com/hcmud136. Registered residents will receive alerts about interruptions to water, sewer, trash service or other pertinent information.

Our next regular monthly meeting is scheduled for Thursday, October 13th, at 5 P.M. We will continue in-person meetings based on the State of Texas open meeting rules. At this time, our meeting will take place in the Deerfield Village Recreation Center Clubhouse although we suggest that you visit our District website at WWW.HCMUD136.ORG for confirmation of the location.

- Make sure your pet has a form of ID on their collar. Key tags are available 3 for \$2.00 at most hardware stores and work fine for pet ID's.
- ☼ Did you know that you can register your pet with Deerfield's Pet Hotline? Call Marie Nugent, 713-818-5799 for a Pet Hotline tag for your pet. The tag has Marie's home and cell phone number. She keeps a log with a photo, breed, pet's name, and your address, and phone contact numbers. A rabies tag is a great ID, but many Vets are not contactable 24/7 and the finder may not able to keep your pet for several days.
- If you have your pet microchipped, make sure you register on the database and keep your information current. Pets have been found wandering around the neighborhood and, when taken to the vet, found they were micro-chipped but the information was obsolete, thus making it harder to contact the owner.
- If you are going out of town and have a pet sitter, let Marie know your pets name, what it looks like (a picture is also great), and a contact number.

**Also-**Please be considerate and pick up your dog's poop when walking your dog. Our greenbelt is there for all of us to enjoy without stepping in dog poop!

- Please make sure your fence is secure so so your pets don't escape.
- PLEASE remember your pets, DON'T leave them in your hot car!

### **Deeds Committee**

We send our "thank you" to all the residents who have been working on home repairs and yard clean up. For homeowners who have not begun the cleanup, please do so. Attention needs to be given to weekly mowing of yards, weeding plant beds, as well as edging of curbs. In addition, pick up any debris in yards and clean up any mold/mildew on the exterior of the home.

The Midterm elections are just around the corner and political signs are allowed. Remember- 1 sign per candidate/ballot through the election date of November 8, 2022. All political signs must be removed within 10 days after the election. Reference the Association policies and guidelines, Section VI, f (1-2).

Have you turned in your project form? Deeds reminds homeowners to submit an Architectural Approval form (AA) to the office PRIOR to starting any repair, improvement, or addition to the exterior of your home or property. The form can be found on the Deerfield Village website under Documents/Deeds Documents at https://deerfieldvillageonline.com/deeds/

or contact the office for information. Deeds works hard to get your request forms approved as quickly as possible but always allow 5-10 days for processing. An AA is required to be submitted to the office if you would like to place a dumpster, POD, or temporary storage unit in the driveway on your property.

Also, NO contractor signs are allowed in resident yards per the Protective Covenants.

Reminder when replacing or installing a new fence that faces the street, visible from the street or common area, the nice flat side of the pickets must face out towards the street/or common area.

Please make sure that all garbage cans and recycle bins are to be REMOVED the same day after trash service has picked up. Trash pickup is on Tuesdays and Fridays therefore, please remember -DO NOT place TRASH OUT PRIOR to the night before. No one enjoys seeing trash sit for long. PUT TRASH CANS AWAY FROM VIEW.

Please evaluate the trees in your yard for pruning or removal if tree is dead. Remember when having a tree removed, have the stump "ground" and remove any stumps as well. No tree stumps are allowed to be visible from the street view and should be removed. Also, keep in mind that a homeowner is liable if any dead tree limbs fall on a neighbor's property and causes damage. Also, any low-hanging tree limbs over the street should be removed especially if the limbs are blocking a streetlight. Also, any tree or shrub needs to be trimmed so as not to obscure oncoming traffic or block the view of streetlights and/or stop signs.

As usual no boats, trailers, campers, or RV's may be parked on a homeowner's property for over 72 hours.

DEEDS meets the 2nd Monday of the month at 7pm in the Clubhouse. The next meeting will be held on October 10th.

**Comments:** Our financials continue to include several budget variances caused by budget timing: certain expenses had been budgeted but not all of the money was not actually spent. We have adjusted for these items to show our true financial condition more realistically. The corrected net income numbers are those hi-lited in the summary above.

Collections: 2022 Regular Assessment: collection rate as of August 31 is 98.0%. This 0.1% better than the comparable rate a year ago, and 0.3% better than the same-date average for 2017 thru 2021. There are still 14 residents who have not made any payments at all toward their 2022 assessment, and if you are among them we would urge you to contact the office to set up a payment plan – yes, you can still do that! And, speaking of payment plans, of the 48 which have so far been set up for 2022 assessments, 35 have now been paid in full, and most of the others are paying on schedule and are in good standing. Five have fallen behind, and we would urge those residents to resume payments right away to avoid incurring additional

charges. In the near future, the Finance Committee will be mailing reminder letters to those who have not begun steps to pay their 2022 assessments or have fallen behind on their pay plans.

<u>2021 Special Assessment</u>: As of August 31, 98.6% of the \$85 assessment per residence has been collected. This assessment was due on December 1 of last year, so if you haven't yet made payment please do as soon as possible. Checks should be mailed to the Deerfield office or dropped off there. If you haven't received your Special Assessment invoice or simply can't find it, please check with the office and we will provide a duplicate.

#### **Assessments: general information:**

**2022 Assessment invoices** were mailed November 8, 2021 and you should have received yours. If you haven't, please contact Cheryl Beisert at Consolidated Management Services, 281-296-9775, to request a duplicate.

2022 Regular Assessment rates are \$915.00 for patio homes and \$835.00 for all others. Payment was due by **January 1, 2022.** Payments received after January 31 are subject to a \$100.00 late fee.

Payment plans are available if it's difficult to pay your assessment all in one lump sum. Contact Catherine at the Deerfield office, 281-463-2624 to set up an appointment to discuss a contract. Payment plans can be set up to cover balances due for 2021 or prior years in addition to the 2022 assessment. If you have an outstanding balance, please make arrangements to pay it off as soon as possible!

Reminder: HOA fees (assessment invoices) are NEVER part of a mortgage escrow. Payment will not be made by your mortgage company, and therefore it is the responsibility of the homeowner to pay.

### **Swim Pool Committee**

Hello Deerfield neighbors. We hope many of you made the most of the summer by swimming in our beautiful pool. The lifeguarded swim season is has ended. As always, we remind residents that you must have a pool ID card registered through the Deerfield office to swim during the open season. If you already have a pool card, there is no need to redo them yearly. The pool ID cards must remain in the pool office. Please do not take cards home. Children over the age of 10 can register for their own Pool ID card and attend the pool without a parent. Residents are allowed up to three guests.

The Swim At Your Own Risk (S.A.Y.O.R.) program, where residents can swim during non-life guarded hours from 6am to 9pm, is still available until November or at least up until the water temperature hits 72 degrees. Please note that there are certain SAYOR pool rules, temperature restrictions, and signing of a waiver required each year for this program. For more information to enroll in the program call or email the HOA office.

Heading into the off season, the Swimming Pool Committee will be focusing on needed repairs and/ or improvements to the pool and deck area. We will be installing a new diving board in the new upcoming 2023 year. It will be customized and is ready to go! ## **Security Committee**

Last month was pretty quiet again from a security standpoint except for a few "crimes of opportunity" incidents where some residents left garage doors open, cars unlocked, and items of value in sight. Unfortunately, every time a perpetrator has a success like this it becomes less safe for all of us as they are motivated to look for another easy situation in Deerfield. Please lock your house and cars, keep garage doors closed, outside lights on and valuables out of sight so that most of the crime in Deerfield can be eliminated.

We have had a few instances of cycling related incidents so I looked up the rules and regulations for Texas that may now prevent these issues from happening again.

#### Texas Bicycle Laws – 8 Things to Know

These "rules of the road" are based on Texas Transportation Code statutes (aka: Texas bicycle laws). Find the complete bicycle code at the bottom of the page. Laws are designed to improve the safety of everyone who uses the roadways. Don't become a statistic! Remember to always use hand signals and body actions to communicate with motorists and other bicyclists.

## 1. Bicyclists have the rights and duties of other vehicle operators: (551.101)

Yes, this means you have to stop at stop signs and red lights, but cars are required to yield right-of-way to a bicycle when appropriate, just as to any other vehicle.

## 2. Ride near the curb and go in the same direction as other traffic: (551.103)

Near the curb is subjective (we recommend leaving a cushion of about three feet) but the law gives a cyclist the right to take the lane when necessary for safety.

## 3. At least one hand on the handlebars (two are safer): (551.102c)

One when signaling but two when turning works well.

#### 4. Use hand and arm signals: (545.107)

Point the way you are going, let the other operators know what you want to do.

#### 5. One rider per saddle: (551.102a)

Don't let your friends share your bike while riding unless you're both on a tandem.

## 6. You may ride two abreast as long as you don't impede traffic: (551.103c)

Racing and taking the lane are special cases.

## 7. Must have a white light on the front and a red reflector or red light on the rear (for riding at night): (551.104b)

The light is primarily so people can see you coming from the side, where their headlights do not shine on your reflectors. The law, effective as of Sept. 2001, states that <u>a red light can replace a red reflector</u>.

### 8. Brakes capable of making the braked wheel skid: (551.104a)

Don't test that front brake to see if the wheel will skid while riding, especially downhill.

#### Bike safety and etiquette on the greenbelt.

The Deerfield Village greenbelt is a wonderful attribute of our neighborhood where runners, walkers, and casual bike riders alike can take advantage of. To ensure you and others have a safe and enjoyable experience, please observe the following when using the greenbelt on your bike.

#### Safety Guidelines

- Pedestrians have the right of way at all times. Cyclists must be aware of pedestrians.
- All greenbelt users should stay to the right and use caution at intersections and at blind corners where vision could be impaired.
- Pedestrians should not walk more than two abreast to allow for easy passage of other pedestrians or cyclists.
- Cyclists and in-line skaters should maintain speeds safe for conditions, slowing down when passing pedestrians
- A person passing other users must notify the users that they are passing example: "On your left." The use of a bell is another option. The person has the responsibility to pass freely and clearly. It is also the responsibility of the passer not to hinder the approaching user.
- Cyclists should have a white front and red rear light displayed and illuminated when riding at night, in addition to the reflectors on your tires, so that pedestrians can clearly see them.
- Pedestrians and cyclists should wear light colored or reflective clothing when using the greenbelt after dark.
- When cycling, always remember to wear a helmet!



## <u>Men's Group</u>

This past month TMG held another successful Food Drive to benefit our local food pantry, Mesa Outreach and we completed some misc. carpentry and electrical jobs. In addition, we did some power washing of the visible stains around the clubhouse and along stairs up to the annex. We also installed edging at several spots along the sidewalk to the school west of Red Lodge where the pipeline sand/silt has been washing off and creating a serious slipping hazard. TMG has completed stenciling the street names on the streets along the greenbelt. Lots of positive comments from residents about the new snazzy two-tone design. We continue to dig channels to let the water run off from the sidewalks along the new water pipeline R.O.W. RECYCLING PLASTIC /FILMBAGS for TREX The manufacturer of our new perimeter fence has a program to recycle plastic films that our regular recycler will not take, i.e. grocery bags, bread bags, newspaper sleeves, etc. A collection bins are located in the gated area by the ice machine at the Rec Center. TREX does this because their material is a composite of wood and recycled plastic. We are sorting clean grocery bags and donating them to Katy Christian Ministries for their food distribution.

PAPER SHREDDING and ELECTRONICS RECYCLING Sat. Oct. 22 from 9am - noon in the parking lot. Once again, this year TMG will be supplying the manpower for this popular event.

<u>FOOD DRIVE</u> This month the Food Drive will be held October 10-15. Please drop off your non-perishable donations in the box outside the office. Water bottles for the homeless can be dropped off at the pool area. The Men's Group (TMG) meets weekly on every

Thursday at 9:00am at the Rec Center. Besides our projects for DFV, and the community at large, we mix in

### **Community Services**

We are in the Hurricane season. Experts are predicting that the 2022 hurricane season will be above average to well above average. High surface water temperatures in the Gulf contribute to development of hurricanes, and the hot, dry weather we have been experiencing has been putting the warm surface water in place. Technically, Atlantic hurricane season runs from June 1 until November 30, but peak season is mid-August through September, and it is not unusual for June-July to be quiet (as they have been this year.) The National Oceanic and Atmospheric Administration (NOAA) predicts 14-21 named storms this year and 6-10 hurricanes, of which 3-6 will be major hurricanes (Cat 3-5). According to Forbes, over the last 10 years the actual numbers have been within NOAA's predicted range 92% of the time for named storms and 82% of the time for major hurricanes.

All that says this would be a good time to go over hurricane preparedness!

Here are FEMA's hurricane season preparation recommendations:

- Prepare to evacuate. Have a "go bag" with medication and clothes, stock emergency supplies, such as a first aid kit and flashlights, secure a place to stay and research your local evacuation routes.
- Safeguard your home. Reinforce and secure your walls, doors, roof and windows. Secure lightweight outdoor objects, such as patio furniture and planters. If you can't carry an item inside, secure these items with an anchor.
- Sign up for local alerts and warnings. Sign up for texts, calls and emails to warn you about a hurricane. You may want to get an NOAA Weather Radio.
- Protect important documents. Use a waterproof container to store all financial documents, insurance cards, medical records, passports, birth certificates and other legal documents.
- Have emergency contacts. It's recommended to have an out-of-state emergency contact, as well as up-to-date contact information for work, school, doctors, non-emergency police, family members and doctors.

FEMA recommends you follow instructions by local authorities, in case of a hurricane. If your local authority advises evacuation, make sure to take your "go bag" and leave immediately. Additionally, do the following to stay safe:

- Stay away from the area until the authorities clear it as safe.
- Call 911 to help yourself or another person in danger.
- Use caution in high winds: stay clear of windows and get to the lowest level of an interior room.
- Steer clear or flooded roads or through water.

If you were here for lke in 2008 or Harvey in 2017, you know not to take hurricane season lightly!

### NEWS FROM THE DEERFIELD WOMEN'S DAYTRIPPERS

#### NOTICE OF TAXPAYERS' RIGHT TO ELECTION TO REDUCE TAX RATE

If the district adopts a combined debt service, operation and maintenance, and contract tax rate that would result in the taxes on the average residence homestead increasing by more than eight percent, the qualified voters of the district by petition may require that an election be held to determine whether to reduce the operation and maintenance tax rate to the voter-approval tax rate under Section 49.23603, Water Code.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.


