

# DVCA Tennis Ball Machine Use & Cleaning Agreement

Thank you for purchasing a ball machine pass. Passes are non-refundable and available only to Members of DVCA. The terms of use are:

- **Disinfecting and Storing:** After each use, the user is expected return all balls to the machine and sanitize their hands prior to wiping down all the components.
  1. Retrieve the ball machine from the room across the Deerfield office, and make sure door is locked after removal and return.
  2. When returning the ball machine to storage, spray and wipe down the handles, knobs and control panel. Spray the towel and not directly on any of the controls or power button.
  3. Place the ball machine back in Small Meeting Room across from the Deerfield office.
  4. After returning the machine, it will need to be plugged into the power for charging.
- **Reservations:** Players are limited to 1 reservation per day – please make your reservation the day prior to use and during business hours. Bookings are on the hour for up to 2 hours. Latest individual reservation allowed is 8 pm. Unit will take 6 hours to charge after use, so reservations should be not made less than 6 hours between each other. **Reservations must be made at the office in person, by phone or confirmed by email.**
- **Ball Pick-up:** The user agrees to place balls back into the (2) ball holders (including stray balls hit into any surrounding areas). Leaving balls on and around the court will result in forfeiture of use privileges.
- **Remote Control:** By this agreement, the user agrees to clean and return the remote to the box after each use. If the remote is lost, or not returned, a fee will be charged for the cost of a replacement.
- **Weather** – The ball machine is NOT available when rain is forecast.
- **No Sharing:** By this contract, the user agrees that privileges pertain only to the pass-holder(s) in regard to the ball machine and designated balls.
- **Release of Liability:** User assumes all responsibility and liability during use and releases Deerfield Village Community Association (DVCA), its Members and employees from any liability for injury or damage to person or property arising from use.
- **Parent Supervision:** Children under 14 may use the machine only under direct parental supervision or by permission of Tennis Committee or the Board.
- **Pass Fee:** Monthly fee is \$15 or \$5 per session in advance. Renewable until the term date below.
- **Failure to comply with this agreement will result in forfeiture of use privileges. No refunds!**
